STATE LOTTERY OFFICE,

10th JANUARY, 1786.

WHEREAS by an Act passed in this Kingdom, in the 19th and 20th Years of his present Majesty's Reign, entitled, "An Act for licensing and regulating Lottery Offices, and other Purposes therein mentioned," it is enacted, That, the more effectually to prevent Frauds and Abuses in the selling of Lottery Tickets in Shares or Chances; each and every Ticket in any Lottery, to be established at any Time or Times after passing said Act, before it be divided into or sold in Shares, should be deposited with the proper Officer to be appointed for that Purpose, and that every such Share and Shares should be duly stamped as therein is mentioned: And that if any Person or Persons should at any Time or Times after passing said Act, sell or expose to Sale any Share or Chance in any such Lottery or Lotteries, without such Share or Chance should have been first duly stamped and marked, pursuant to said Act, that then, and in such Case, every such Person and Persons so offending should forfeit and pay the Sum of One Hundred Pounds Sterling for each and every Share and Chance so sold or exposed to Sale, as therein mentioned.

And whereas by an Act passed in the last Session of Parliament, entitled, "An Act for amending the Laws for regulating Lottery Offices," it is enacted, That Tickets and Shares of Tickets in any British Lottery or Lotteries shall be sold under the same Rules and Regulations, and under the same Prohibitions and Restrictions, as are prescribed, directed and appointed for selling Tickets and Shares of Tickets in any Lottery established, or to be established, by the Parliament of this Kingdom.

Now the Managers and Directors of the Irish Lottery think it necessary to caution all Persons whatsoever from buying or selling any Shares or Chances of Tickets, under any Denomination whatsoever, without such Shares or Chances shall be duly stamped as the Law directs, being determined to prosecute with the utmost Rigour, all Persons both in Town and Country, detected in vending or retailing any such Shares or Chances, the same being illegal, and an Imposition on the Public.
