

son, whether steps had been taken by the administration in England, to procure for this or a removal of the obstructions to our trade with Portugal.

Secretary Orde answered the hon. genl. by saying, that since the additional duties laid on by the Irish parliament on goods of Portugal, some steps had been taken by the administration in England, to induce the gov. of Portugal to relax in her disposition towards this country; it was at present under consideration, but he hoped the event would be favourable to this kingdom.

Corry said the inattention of Parliament in last sessions, and also in the present, to the subject was highly blameable; he insisted the interest of this country was neglected by the British minister; last sessions of Parliament had moved for copies of the treaties existing between Great Britain and foreign powers, they were refused him; we are driven to war with Portugal without England interposing in our cause. Here he took notice of the business was hurrying so fast through the House, that the sessions will end in a very short time, and if something is not done, in respect to the duties, in the course of this session, this country may be materially injured before the next session.

Lucius O'Brien was also of opinion, that the country had been neglected by the administration in England in the Portugal business; he moved the House should come to some resolution on that head.

Corry then moved, that a committee be appointed to enquire into the collection of stamp duty on advertisements.

Mr. Naas objected, and said there was no probability for appointing a committee for that purpose, as he was then ready to give the hon. gentleman such information as he wanted; he moved that appointing such a committee was unnecessary.

Corry replied, that if information was desired that House, there was an end to the matter.

Mr. Naas, in order to get rid of the business, moved the question of adjournment, to Monday, which was carried.

At the request of Mr. Corry, the Chancellor of the Exchequer moved the duty on newspapers, advertisements, &c.

Mr. Corry observed, it was rather an embarrassment to him to state the difficulties and objections of the tax on the printers and the public, as the information had been denied. He stated from the petition, which he presented, the grievances of the printers, that they were considerable losers by the sale of their papers, from the expence of printing, paper, &c.

The Attorney General spoke in favour of the continuance, as no hardship on the poor or the printer.

Mr. Forbes, Mr. Brownlow, Mr. Burgh of Galloway, Mr. Todd Jones, and Mr. Kearney in support of Mr. Corry's motion, who moved to discontinue the stamp duty after the first ten days, so that every advertisement might pay no less than the duty as at present.

Chancellor of the Exchequer presented his resolution for taxing Insurances from Fire, with reasons in support of it. [Here it is necessary to observe, that besides the 3 Irish Insurance Companies, the merchants, &c. of Dublin, Limerick, Cork, and other places, had petitioned against the tax, but which were declined to be either presented or received, as militating against the usage of Parliament.]

Mr. Hartley, Sir F. Hutchinson, and Mr. Corry objected to the tax.

The Chan. of the Exchequer observed, that gentlemen had no new taxes to cavil at, they abused themselves in opposing old ones.—The motion was then negatived, by the resolution as originally stood being agreed to without a division.—The other resolutions were then agreed to, and the report ordered to be received tomorrow.—Adjourned.

Belfast, Feb. 9. We hear that a dreadful battle was fought on the banks of the Lagan river, near Spencer's-bridge, in which many hundreds of combatants were engaged, and several so dreadfully wounded and bruised that they were obliged to be carried off the ground on doors and planks. This unhappy affair originated from an old dispute between the people of the manor of Kilwarlin and those of Trillick and Broombridge, and in consequence of which a dreadful battle was fought on the banks of the Lagan about seven or eight years ago, in which many lives were lost.
