The Grand Jury of the County Clare were sworn this day at Ennis for fiscal business before the High Sheriff, and on Tuesday next they will be re-sworn before the Honorable Justice Crampton, who will preside in the Criminal Court.

The Grand Jury of the City Limerick will be sworn at the Tholsel before the Sheriffs, at 3 o'clock on Friday next. Mr. Justice Crampton will preside in the City Limerick Court, and Mr. Sergeant Greene in the County.

The Grand Jury of the County Limerick will be sworn before the High Sheriff for fiscal business, at the County Court-House, on Friday next at ten o'clock in the forenoon.

There is only one case of Nisi Prius as yet set down for trial at our City Assizes, viz. Devitt v. Gough.

The Grand Jury of Kerry will be impanelled for the discharge of their fiscal duties, at twelve o'clock on Thursday the 12th of March, at Tralee.

Sub-Constable Michael Shanahan and Sub-Constable John O'Grady have succeeded in arresting John Mara, one of the persons charged with the murder of Rodger Buckley, at the fair of Pallas Grean, in this County, on the 24th November.

The Cork and Dublin Mail Coach, *via* Cashel, was upset Monday morning, at four o'clock, four miles at the Cork side of Caher and thrown into a gripe, occasioned by the violence of the wind, which actually forced the coach and horses off the road ; no blame can be attached to the driver who was perfectly sober. The passengers, four inside and two outside, escaped with very little hurt but remained in a wretched hut until morning. The coach was raised by the assistance of a number of men, and proceeded on its journey in about six hours. Some of the passengers travelled in a chaise as far as the first stage, and arrived in Cork at three o'clock.
