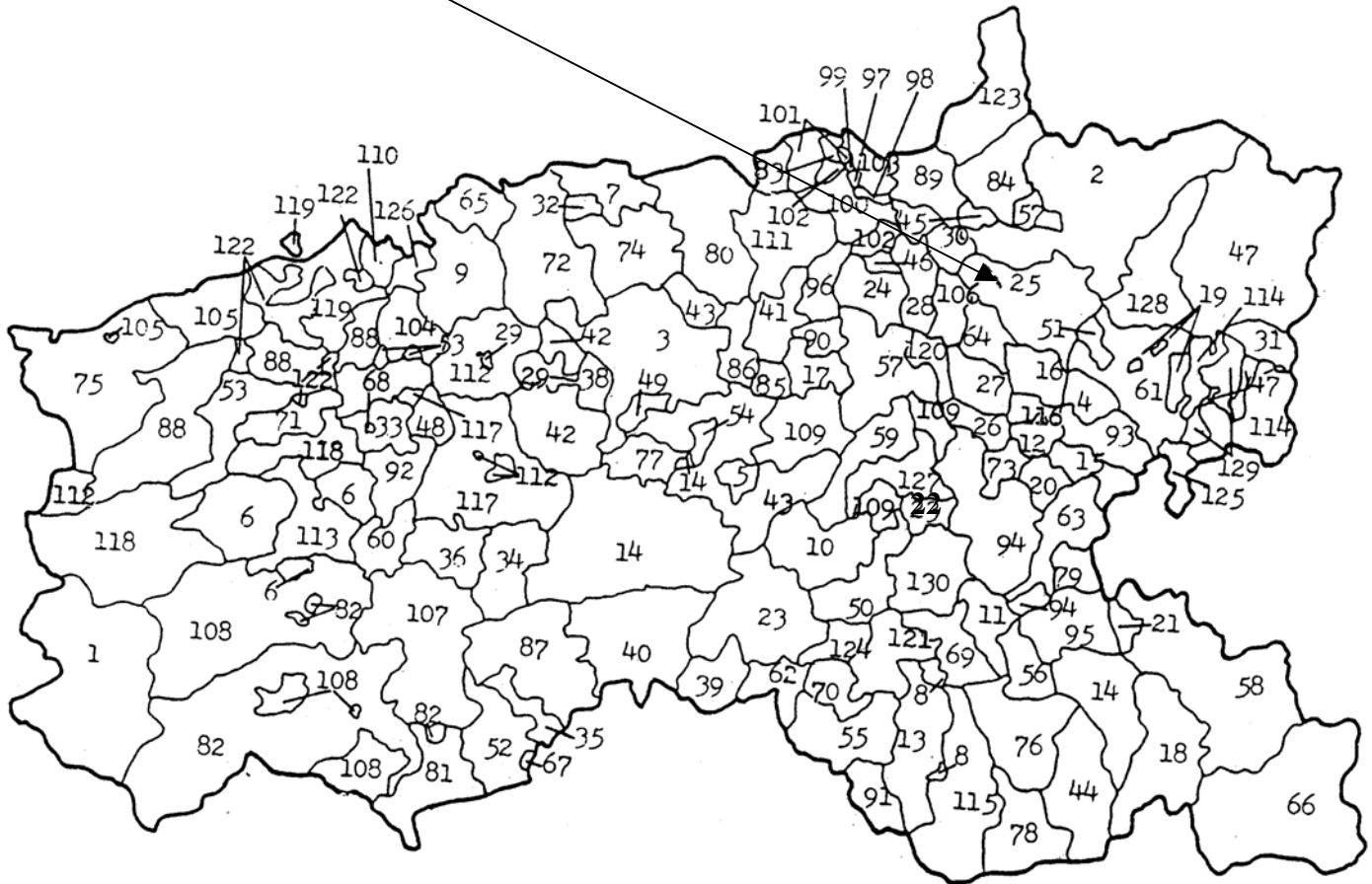

Boher na Collie took its name from an old woman who hanged herself there of old. It was levelled later than King William's Road, part as late as 1830.

The dead were buried on the hill, which thenceforward was called Cill an Iubhair, the burial-ground of the yew.
