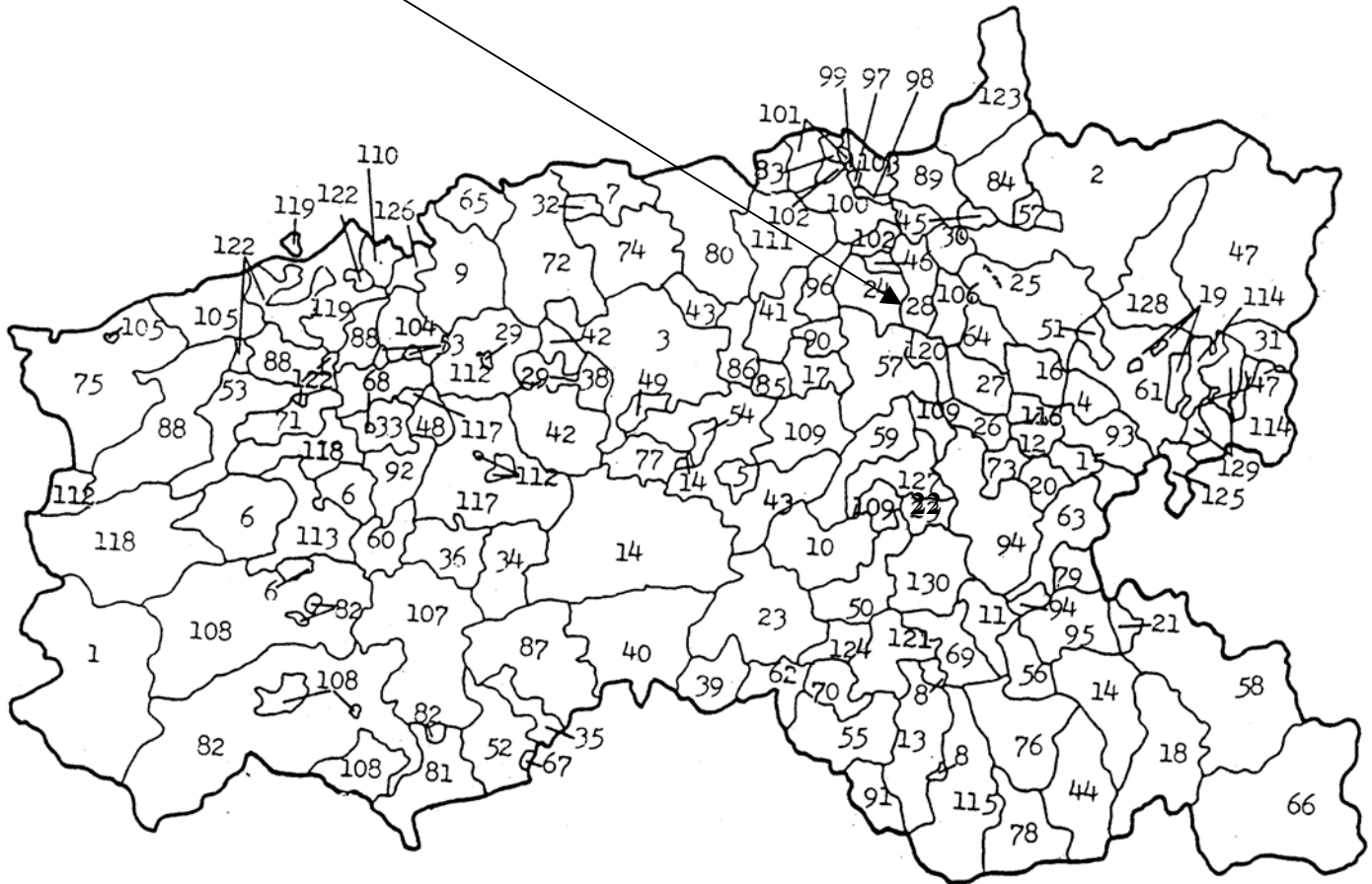

This parish is partly in the Barony of Clanwilliam, but chiefly in the County of the City of Limerick. It is about 5 miles S. from the city of Limerick. It is bounded on the E. by the phs. of Ludden and Carrigparson; N. by Derrygalvin and Donaghmore phs.; W. by Caheravally and Fedamore phs.; and S. by the ph. of Rochestown.

The parish is about  $4\frac{1}{2}$  miles long and one mile broad. It contains 2,478 acres, divided between 14 townlands. The surface is very level, and the land good arable. It is well accomodated with roads, the principal of which is that leading N. and S. through its centre from Cork to Limerick.

Situated in the N. end of the parish. Bounded on the N. by Donaghmore ph.; E. by Drombanny td.; and on the S, and W. by Drombanny td. This townland, which is Bishops Land, contains 58 acres. The soil is partly deep, producing potatoes, corn, flax, and some wheat. Limestone is burned and used for manure.

The proprietor John Farley, Esq. has it let at will to 10 tenants in farms of 14 to 2 acres at £3 3s. per acre. Co. Cess generally 4s.6d. to 5s. per acre  $\frac{1}{2}$ -yearly. Tithe not paid since 1834. Bog used for fuel is very scarce.

Soil partly deep, with limestone, producing potatoes, corn, wheat and flax. The proprietor Lord Gort has it let per his agent Recorder W. Smyth, Limerick, to 8 tenants by leases of 3 lives at £2 2s. per acre in farms of 20 to 2 acres. Co. Cess generally 4s.6d. to 6s. per acre  $\frac{1}{2}$ -yearly. Tithe 1s.8d. per acre. Bog used for fuel is very scarce. Prevailing Name - Hute.

The proprietor Pierce Mahony, Esq. has it let per his agent Captain Kane to 12 tenants by leases of 1 life and 21 years in farms of 35 to  $1\frac{1}{2}$  acres at £2 2s. to £1 10s. per acre. Co. Cess 4s.6d. to 6s. per acre  $\frac{1}{2}$ -yearly. Tithe 1s.8d. per acre. Bog used for fuel is very scarce. Prevailing Name - Hartigan.

Contains 60 acres, of which about 20 are bog and rough pasture, the rest arable. The soil is partly deep, with limestone, producing potatoes, corn, wheat and flax.

The proprietor Jonathan Cripps, Esq. has it let at will to 9 tenants in farms of from 3 $\frac{1}{2}$  to 2 acres at £3 to £2 15s. per acre. Co. Cess generally 4s.6d. to 6s. per acre half-yearly. Tithe 2s.1d. per acre. Bog used for fuel is in abundance.

Contains 259 acres, of which about 12 acres are rough ground, the rest arable. The soil is partly deep, producing potatoes, corn, wheat and flax.

The proprietor Thomas H. Royse, Esq. has it let to William Howly, Esq. by a lease for ever, and he again to 11 tenants, 3 with leases of 1 life, at £2 5s. per acre in farms of from 40 to 2 $\frac{1}{2}$  acres. Co. Cess as above. Tithe not paid since 1834. Prevailing Name - Fitzgerald.

In the S.E. end of the parish. Bounded on the N. and W. by the td. of Cahernarry (Cripps); and on the S. and E. by Scart td. Contains 60 acres, about 10 of which are bog and rough ground, the rest arable. Soil partly gravelly, producing potatoes, corn, flax and some wheat.

The proprietor Pierce Mahony, Esq. has it let to 2 tenants by leases of 3 lives at £1 15s. per acre. Co. Cess as above. Tithe 1s.8d. per acre. Bog used for fuel is in abundance.

This townland is in two parts, one in the west end of the parish, containing 465 acres, and a small detached portion of 17 acres in the east end. Each part is equally arable, and produces potatoes, corn, flax and some wheat. The proprietor Matthew Barrington, Esq. has the first part let to 16 tenants, 6 with leases of 3 lives, in farms of 29 to 2 acres at £2 2s. to £2 15s. per acre. He has the second part let to 2 tenants at £2 2s. per acre by leases of 3 lives. Co. Cess 4s.6d. to 6s. per acre  $\frac{1}{2}$ -yearly. Tithe 2s.8d. per acre. Bog used for fuel is very scarce.

Dwyer, Esq. has it let to Edward Fitzgerald, Esq., who has part of it in his own occupation, and the remainder let to 5 tenants by leases expiring in 1845 and 1850 at £2 15s. to £3 5s. per acre. Co. Cess generally 1s.6d. to 1s.8d. per acre  $\frac{1}{2}$ -yearly, and tithe £5 15s. gross. Bog used for fuel is very scarce.

In the E. end of the parish. Bounded on the E. by Ludden ph.; on the S. and W. by Ballynagarde td.; and on the N. by Knockea, Edwardstown, Knockbrien and Ballyneety tds. Contains 249 acres. Arable. Soil light and gravelly, producing potatoes, corn, wheat and flax. Limestone is burned and used for manure.

The proprietor John S. Dwyer has it let to Abigail Brisco, and she again to 10 tenants by leases of 3 lives & 21 years at £3 5s. to £2 15s. per acre in farms of from 70 to 1 $\frac{1}{2}$  acres. Co. Cess generally 1s.4d to 1s.8d. per acre  $\frac{1}{2}$  yearly. Tithe 2s.3d. per acre. Bog used for fuel is very scarce. Prevailing Name - Kennedy.

Soil deep, with some limestone, producing corn, wheat and flax, with potatoes. The proprietor Lord Gort has it let by lease of 3 lives at £2 5s. per acre to Mr. Michael Shine, in whose own occupation it is. Co. Cess 1s.4d. to 1s.8d. per acre  $\frac{1}{2}$ -yearly. Tithe 2s.3d per acre.

In the W. end of the parish. Bounded on the N. and W. by Caheravally td.; E. by Edwardstown td.; and S. by Glen td. Contains 62 acres. Arable. Soil light, with limestone, and produces potatoes, corn, wheat and flax.

The proprietor Pierce Mahony, Esq. has it let to Mr. John Synan, who retains it in his own occupation, by a lease of 3 lives at £2 2s. per acre. Co. Cess 1s.4d. to 1s.8d. per acre  $\frac{1}{2}$  yearly. Tithe 3s. per acre.

This fort is about 2 chains in diameter, circular, and composed of earth, with a green flat surface. It is about 3 feet high. It is situated in a low plain and is not, therefore, in view of any other forts.

In the N. end of Cahernarry (Keane) td., attached to, and on the north side of, the road from Caherconlish to Limerick.

This well is about 24 feet in diameter, is circular with a wall 3 foot high round it, and is shallow with a gravelly bottom. It is esteemed the more by the inhabitants because of its pure spring water, as because of the legendary saying that "it removed formerly from a small hill at its south side, a distance of about a  $\frac{1}{4}$  mile, in which hill the form of the well is still retained."

This church is situated in the north-west corner of the td. of Cahernarry (Cripps), and to the west of the old road from Cork to Limerick.

It was rebuilt in 1809 at the expense of £350 by the Board of First Fruits, and it is capable of accomodating about 60 or 70 persons. It has a grave-yard attached to it.

Cloch a' Bhrúnaigh, Brown's stone or castle. This is the correct form of the name. J. O'D.

Situated in the north end of Drombanny townland, near the western boundary of the same, and about  $\frac{1}{2}$  a mile N.W. of Lissaniska.

This is in the form of a circular fort, being about  $2\frac{1}{2}$  chains in diameter and 3 feet high, with a flat surface partly covered with hawthorn bushes. It is believed by the natives to have been a graveyard in olden times, in which was also a House of Worship; and as some proof of this they have frequently during 1837-8-9, while digging for gravel, exposed vast quantities of human bones.

This house, which is situated on an eminence, was built in 1809 by Jno. Massy, Esq. at the expense of about £300. It is 2 story high, and is now the seat of Mr. Cornelius Cleary.

This house was built between 1750 and 1769 at the expense of about £600. It is 2 story high, and is situated in a valley. It is now (1839) the seat of Mr. Michael Shine.

The ruins of this castle are situated in the middle of the west boundary of Drombanny townland.

The inhabitants say that long ago it was inhabited by one Thomas Power, who possessed amongst other properties the lands of Drombanny. He was attacked by invaders and had to fly for refuge to Slieve Luachra. On his return, he found his household all slain. However, he ended his life in the castle, after which it decayed gradually to its present state. Such is the local history (?) of the castle, a recasting probably of an ancient folk-tale.
