Yeast, or Barm being often not to be had, the following approved process, of making Leavened Bread, is laid before the Public; if Yeast should be added, one fourth part of what is commonly used, will answer the purpose. Part of the Flour intended for this kind of Bread, being made into Dough, with warm Water, and a little Salt, is laid in the rest of the Flour, an hour, or more, in which time it rises to three times the bulk; then they mix and knead the whole with more Water, till it is brought into a stiff Dough, which being formed into Loaves, is baked in the Oven: tho' the more usual way is to take a piece of the kneaded Dough, and leave it covered with Flour, till the next time, then break it small, and mix it with the Flour, adding some Yeast, warm Water and Salt, as above directed.
