Mr. Forbes moved for leave to bring in a bill to limit the amount of pensions. Chancellor of the Exchequer said he was always happy when he could comply with the wishes of gentlemen: he saw nothing in the title of the bill that could induce him to oppose giving leave to bring it in, therefore the Hon. Gentleman had his consent, though he did not think himself bound to remain silent, if, when the bill appeared, it should contain exceptionable matter.

Mr. Brownlow then produced a string of resolutions. The first was,
Resolved, That the amount of pensions for two years, ending Lady Day, 1757, was 89,481l.
The Chancellor of the Exchequer said, he could not see the use of repeating what was already on the Journals, especially at this period of the sessions, after Parliament had provided for the pension list, and passed without animadversion; besides—there were many facts which might have led Parliament to a resolution nine and twenty years ago, which were now forgotten. He moved, that the consideration of the question be adjourned to the first of August.
The House divided, Ayes for adjourning the question, 128—Noes, 67.

DUBLIN, March 11.

Letters from London of the first authority by Tuesday's packet advise the young minister had declared to his friends, that if he had not carried the shop tax with more than fifty voices, his resignation would certainly have followed. It is however the general opinion that a ministerial change is an event not very distant.
His Majesty, by his Royal Letters, having appointed Charles Dillon, Esq.; now called Charles Dillon Lee, to be of his Most Honourable Privy Council of this kingdom, he on Saturday in Council took the usual oaths, and his place at the board accordingly.

Extract of a letter from a Gentleman in Ballyshannon, March 3
"I am sorry to acquaint you, that on Tuesday last, our great market day, an absurd Revenue-officer took a party of the 49th regiment, to seize whiskey in the suburbs. As the country people were intoxicated, a scuffle ensued, when the latter drove the party into the barracks, from whence they sallied, and fired balls in every direction, through the several streets, and over the bridge, among a multitude of innocent persons, by which two women and one man were killed, and a vast number most dangerously wounded."

Last Saturday between the hours of seven and eight in the morning, a servant maid belonging to the family of his Grace the Duke of Rutland, together with a boy was riding through the Phoenix Park on a sumpter cart; a footpad stopped them and presenting a pistol to the woman's breast, demanded her money; she gave him a Guinea which she declared was all she had; the fellow then opened the cart to search for booty, and the better to do it, he laid the pistol out of his hand on the cart, which the woman instantly seizing, fired at the robber; the ball took place in his head, and stretched him on the ground, when in a few moments he expired. Our gallant footpad however unscathed.

Last Wednesday the body of Mary McCarthy, who fell into the river at Thomond-bridge, the 23d of January last, was taken up near Askeaton.
