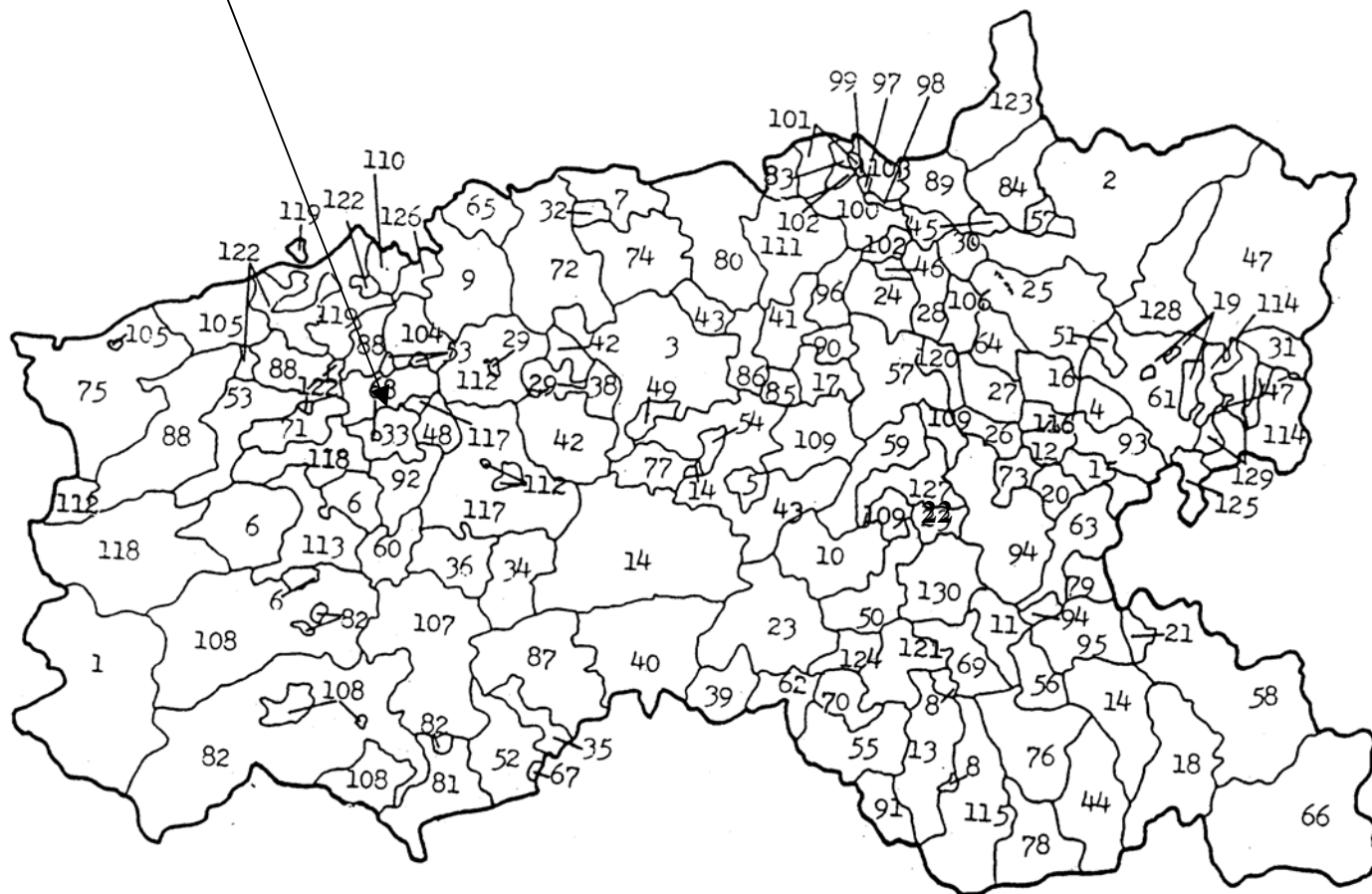

Situated in the N. of the Co. of Limerick. It is bounded on the N. by the phs. of Kilmoylan and Dunmoylan; S. by Liscannel; E. by Doondonnell & Rathkeale; and W. by Rathronan. Contains 2,428 acres.

This parish is of a rectangular form. Its greatest length from N. to S. is 2 m. 5 fur., and breadth from E. to W. is $2\frac{1}{2}$ miles. It is traversed from N. to S. by a principal road together with another road leading from it to the S.E. A considerable portion of this parish is coarse pasture, used as grazing. There is no bog.

Situated near the Chapel in the td. of Coolcappagh. This is a rectangular building, 2 story high in front and 3 story high in rear. In good repair, and was erected in 1792 by William Enright, father of the present occupier William Enright.

The Residence of John Creagh, Esq. It is a rectangular building, 1 story high and in good repair. It was erected about 65 years ago by the late John Creagh, father of the present occupier. Attached to it are a set of offices, a plain garden, and some trees.

These ruins are of rectangular form. The walls, about 25 feet high, are standing and perfect, but appear to have formerly been higher. A spiral staircase in a good state of preservation gives access to the top.

This is a rectangular-shaped building, 2 stories high, formerly slated, but now thatched and in bad repair. It is the residence of Philip Ebzery.

In ruins. Of rectangular form and 2 stories high. Except for one breach in the west wall, the walls are all standing and perfect. This was formerly the residence of Colonel White.

This church was erected in 1835 by the Revd. Darby MacEgan. It has two wings, giving it the appearance of a cross, and can accomodate 600 persons.

In the east of Lissnacullia td.

A large rectangular building, 3 stories high, with a square tower at the S.E. angle. The walls are all standing and in a good state of preservation. By means of a spiral staircase in the square tower access to the top can be obtained. To the south stands a smaller building, 2 stories high, which appears to have been portion of a larger one. Its walls are all standing and perfect.

These ruins are of a rectangular form. The west wall is down to the foundation, which can only be traced; the other walls are standing, but in a dilapidated state. There is a graveyard attached to the ruins, containing about 6 chains or something better than half an acre.
