DUNGARVAN.

REPORT upon the PROPOSED MUNICIPAL BOUNDARY of the BOROUGH of DUNGARVAN.

THE Manor of Dungarvan is supposed to contain about 10,000 Statute acres. Ancient Limits The Limits are ill defined.

Dungarvan is a Sea Port in the Barony of Decies, County of Waterford; its Description or Harbour is defective; its trade consists chiefly in the export of provisions. The Town. Town is at present considered to be in rather a prosperous and improving state.

It is ill supplied with fresh water. There is a Fever Hospital and a Medicine Dispensary for the Poor.

The Population of the Town, according to the Census of 1831, is 8,381. Population. The Population of the Town and Manor taken together, is supposed to amount to 11,858.

Local Rates.

Dungarvan is rated with a portion of the general County Assessment (seven and County Rate. a half ploughlands). The Rate per ploughland in the approved presentments of Summer 1835, as affecting Dungarvan, was 24 l. os. 10 3 d. The Rate at Spring Assizes 1835, was within 1 s. 3 d. of the same amount.


The total charge upon Dungarvan was therefore about 360 l. for the year. Many of the most destitute class are called upon to pay a portion of this tax, which they are unable to pay; the consequence is, that there is generally a deficiency of 31 l. at each Assizes, which it is impossible to collect.

The following Boundary will embrace the Town, and allow sufficient space for any future probable increase:

From the Cunnigar Point (1) in a straight Line to a Gateway (2) marked Proposed by two Pillars on the Sea-shore South of the Town, about One hundred and Boundary. sixty Yards to the South of the House of John Condon; thence in a straight Line to another Gateway (3) marked also by two Pillars on the Eastern Side of the new Road to Youghal, about Three hundred Yards from the Point at which the New Youghal Road leaves the Mount Odell Road; thence in a straight Line to Cromwell's Mound (4), otherwise called Gallows Hill; thence in a straight Line to the Northern End of a Wall on the Edge of the River, about One hundred and ten Yards North of the Monks' School House (5); thence in a straight Line across the River to the Point (6) Northward of the Hospital (about Fifty-six Yards distant from its North-west Angle), where the Garden Wall of Hospital meets a Bank near the Edge of the River; thence in a straight Line to the Southern End of a small Plantation (7) on the East Side of the Waterford Road, belonging to Mr. Boate, about Two hundred and Twenty-four Yards on the Town Side of the Entrance to his Grounds; thence in a straight Line to the Point at which a Bye-road which runs Northward nearly at right angles from the Road between the Roman Catholic Chapel and the new Vicarage House, makes an Angle (8) in turning to the West; thence along the said Bye-road to the Point at which the same joins the Road (9) between the Roman Catholic Chapel and the new Vicarage House; thence along a Fence which runs down to the Sea from opposite the Point last described, to the Point at which such Fence meets the Sea-shore (10); thence in a straight Line to the Cunnigar Point aforesaid.
