This parish is situated in the north of the County of Limerick. It is divided by the parishes of Cappagh and Clonshire into two portions, a northern and a southern. The northern portion, which comprises the townlands of Ballincurra, Ballinvira, Ballynagool and Lisnamuck, is in greatest length $2\frac{1}{4}$ st. miles and in greatest breadth $1\frac{3}{4}$ st. miles. The southern portion, which includes the great bulk of the parish, is in greatest length $3\frac{1}{2}$ st. miles and in greatest breadth $3\frac{1}{2}$ miles. This southern portion is bounded on the N. by the phs. of Cappagh and Clonshire, S. by the phs. of Rathkeale and Ballingarry, E. by the phs. of Adare, Clonshire and Kilfinny, and W. by the phs. of Rathkeale and Nantinan.

The greater part of the parish is made up of good tillage land; the remainder is meadow and pasture. The road from Limerick to Rathkeale runs through the interior. The village of Croagh, now of little importance, was once a corporate town. It comprises 8 acres, and forms part of 3 townlands - Groagh, Ballycannon and Adamswood.

The living is a rectory in the Diocese of Limerick, and forms the corps of the prebend of Clonshire. The parochial church, situated in the village, is very old and is in a considerable state of dilapidation; and the Glebe House, a handsome residence, was erected in 1831. In 1834, there were 73 Protestants and 3,379 Roman Catholics in the parish.
