Extract of a letter from Lisbon, May 4.
"The Queen has taken off the imposts upon tobacco, so far as relates to the English vessels; by which they are not liable to be seized, as formerly, for having a few pounds of British Nicotiana on board. The reason of this heavy tax was a wish to encourage the Brazil tobacco, which was by far too acrimonious for our use."
We can assure the public, that the treaty between England and Russia is concluded, and will soon be made public. It is the most advantageous which has hitherto been negotiated.

DUBLIN, May 27.
MILITARY PROMOTIONS.
5th foot, Capt. Lieut. Jos. Bunbury, from 49th, to be Capt. vice Hawkshaw, resigned. Lieut. Henry Conran to be Captain-Lieutenant, vice Bunbury.—Ensign J. Athenleck to be Lieutenant vice Conran.—Mr. John Webb to be Ensign, vice Athenleck.
The trial of Mr. Fitzgerald is certainly appointed for the 7th of next month, at Castlebar, as the application for trial in Dublin could not be complied with for the following reasons: There are twenty-two persons to be tried for the murder of Mr. M'Donald and Mr. Hypson, besides Fitzgerald, and each having, by law, the right of challenging a certain number of those impanelled as jurors, little less than the attendance of all the freeholders in the county of Mayo would be found necessary; a matter totally impracticable.

Mr. Fitzgerald's mother, we hear, has been for some time past at Turlough-house, and is very industrious in making every disposition that may tend to her son's benefit.
It was reported through town yesterday, and the day before, that the noted Brecknock had died last week in Castlebar gaol, owing to his having refrained from taking sufficient sustenance. Whether the report be founded in fact, we know not, but it is pretty generally credited.

From the great number of witnesses to be examined on the trial of Mr. Fitzgerald, and the other persons charged with the murder of Mr. M'Donnell and Hypson, it is probable that it will engage the court for several days. There is most certainly a very great impropriety in suffering a jury to disperse after having been once impanelled, and hearing evidence on a Common Pleas, in the case of Newburgh and Burrows, and it can only be justified by necessity; an instance of a similar nature is not within our memory, except that of the Earl of Anglesea. There should therefore, be some remedy devised, and although it is an absolute impossibility for any Bench or Jury to attend their duty on a trial for two or three days and nights successively, yet surely some provision might be made for keeping the jury together, and for preventing any person from having access to them; no man who sets a true value on that inestimable privilege, the right of the people to a trial by jury, if impanelled, would deem such confinement a hardship.

Possibly it may be thought, that a jury would be above corruption—for the honour of human nature we must think to—and that this precaution would be unnecessary.—But upon the same principle we should neglect all precautions; it is most undoubtedly necessary to obviate every thing that may lead to temptation, and preclude every means that may give an opportunity for tampering with jurors, or open a door for seduction; for we all know—*humanum est errare*.

All the balloon apparatus belonging to Vincent Lunardi, Esq, has arrived in our bay, and is now on board the Fenor, along with a complete and very large balloon. It is reported, that Mr. Lunardi is on his way, to pay us a visit, in order to make an attempt at crossing the channel. Ranelagh it is thought will be the place fixed on for management of the necessary business.

There are two Corps of Cavalry now forming in the county Carlow, and nearly completed to the number of 100 each, one to be commanded by Beauchamp Bagenal, Esq; and the other by Sir Charles Burton;—another happy proof, that the volunteer ardour, will, as every virtuous Irishman wishes, be rendered perpetual.

Waterford, May 26. The 49th regiment, now quartered in this city, we hear, will be reviewed here either on the 10th or 12th of next month, by the commander in chief of his Majesty's forces in Ireland, general Pitt.

The general is to be either preceded or accompanied by the Hon. Mr. Cuffe; when the site for building the barrack on, it is said, will be finally determined on. But it is confidently reported the building of it will certainly commence this summer.

Cork, May 25. About 12 o'clock last night, Connor, Esq; was met at the end of Harper's-lane, by three footpads, who robbed him of a gold watch, with very valuable gold seals, and 16 English shillings, with which they made off.

This morning were apprehended and lodged in Gaol, by Mr. Rowland Sharp, Peace-Officer, John Murphy and Michael M'Carthy, charged with robbing Mr. Edward Fitzgibbon, about 10 o'clock last night on the potatoe quay of 11, 16s, 7d, and a silver watch.

The prosecution not being complete, she escaped punishment last assizes, and after robbing Mr. Jackson, went to Nenagh; there she proceeded to sell the goods considerable worth twenty guineas, for forty shillings; this caused a suspicion, and she was apprehended and committed to Jail, with two other women who assisted her, by — Gafon, Esq; who has secured a great part of the property.

He is gone to meet that glorious welcome, "Well done, thou good and faithful servant." Well left to his clerical brethren, an example highly worthy of imitation. "Vix ætas ulla habuit parenti nulla superiorem."
