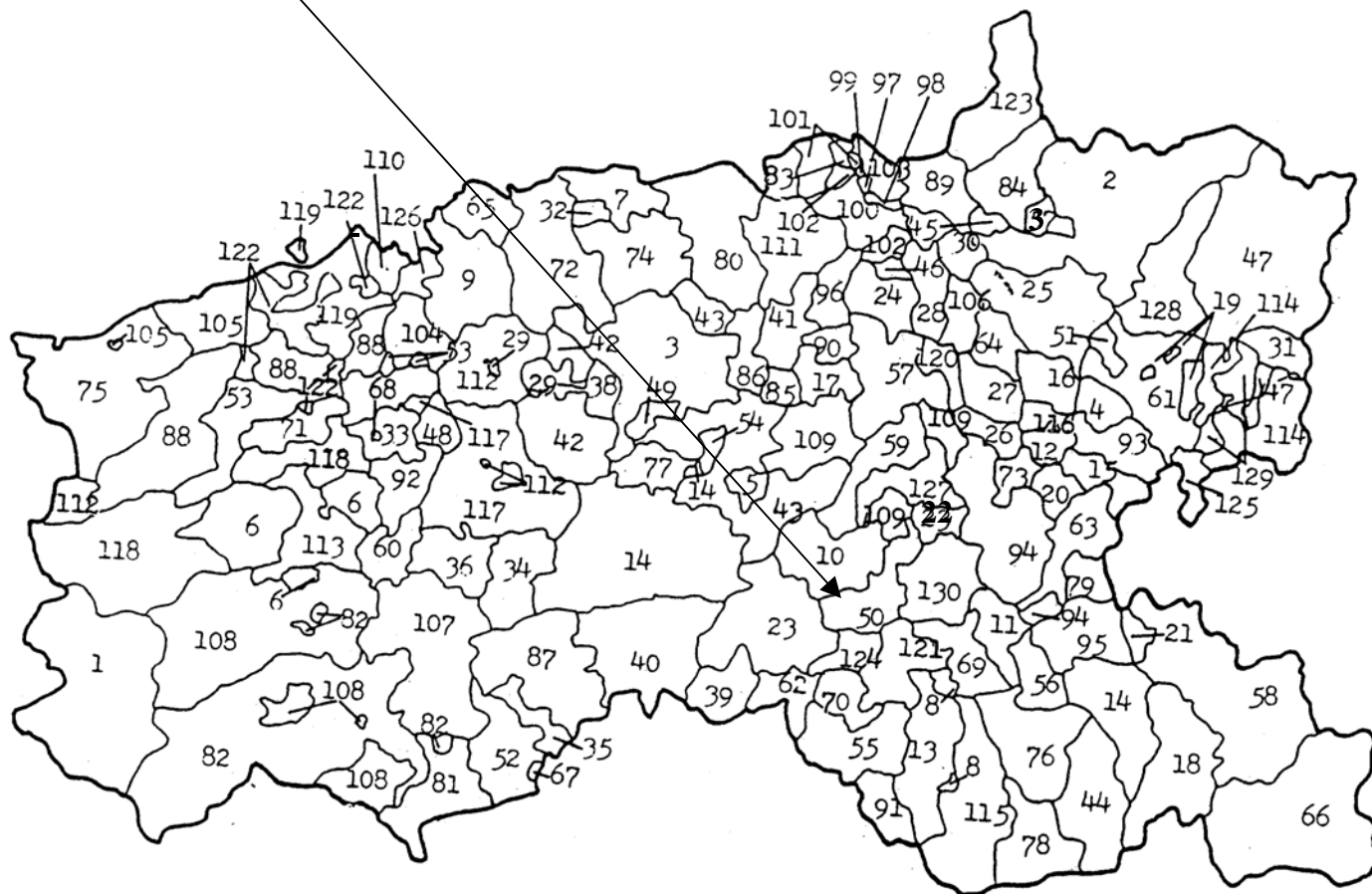

It is the property of Lady Langford, England, and contains 478 acres. There is an ancient fort in this townland. There is also a Trigl. Station, called Cloonygarra, on the E. boundary. In the N.W. end of the townland is a well, called Trinity Well.

It is the property of the Revd. Mr. Croker, Athlacca. It contains 41½ acres, all arable land. There are a Church ruins and a graveyard in the N. end of the Glebe, and a fort near the west boundary.

It is the property of Lady Langford, England, and contains 379 $\frac{1}{2}$ acres, including about 12 acres of plantation. In the central part of this townland are Maidstown or Ballyvenogue Castle, and a Trigl. Station, called Maidstown. There is an ancient fort near the S.W. boundary.
