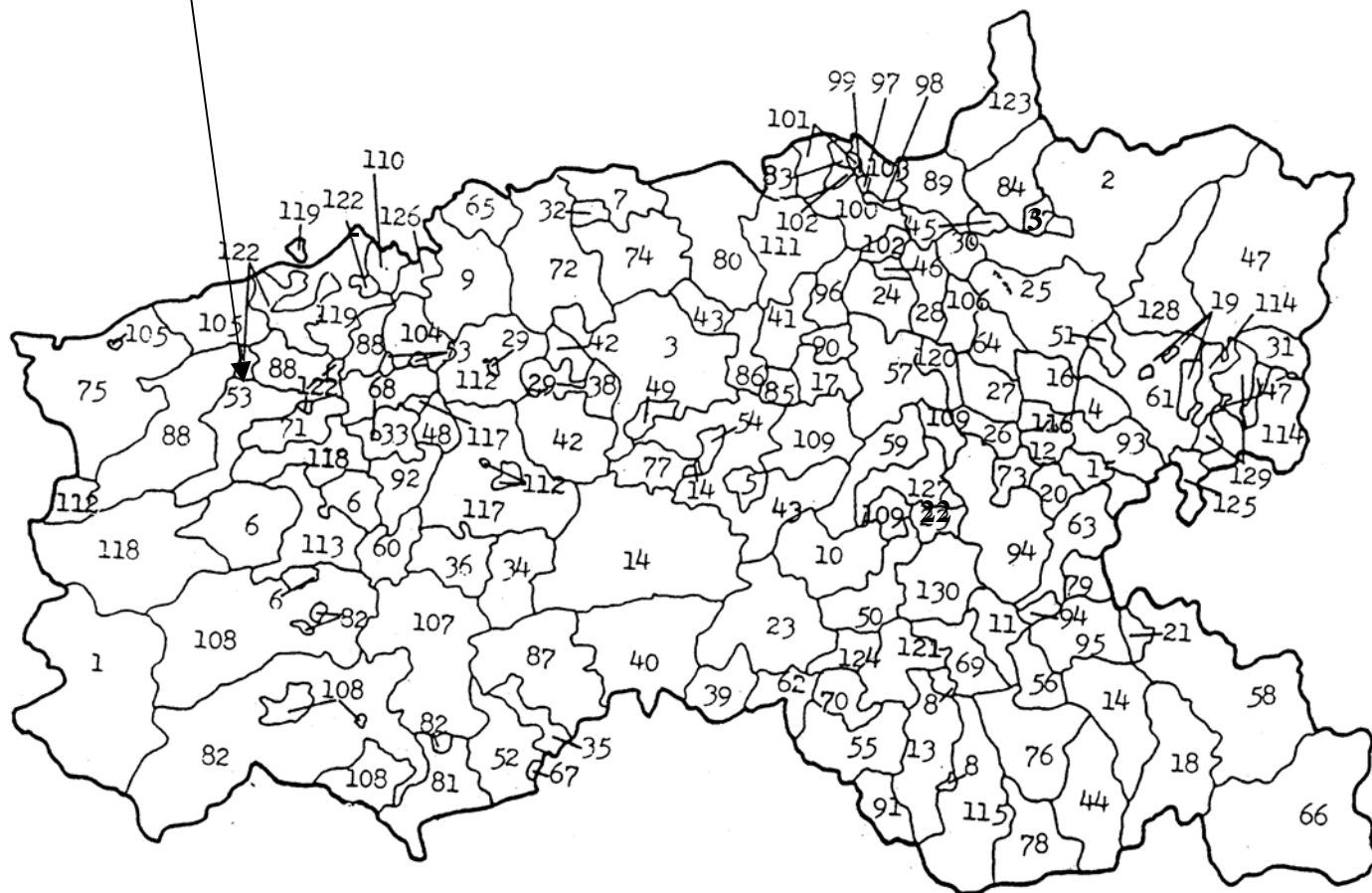

This is a central parish in the Barony of Shanid. It is bounded on the N. by the phs. of Shanagolden and Kilmoylan; E. by the phs. of Kilbradran, Kilcolman, Rathronan (2nd Divn.) and Ardagh; S. by the ph. of Rathronan (1st Divn.); and W. by Kilmoylan ph.

It contains no Protestants, but has 1,000 R.Cs., according to the information procured by averaging the families at 5 persons each. The crops generally sown are potatoes, oats and some wheat. The corn is generally carried to Rathkeale for sale, where it is bought and carried to Limerick for export. The soil is tolerably good towards the North, but bad towards the South. Lime is much used for manure in the south part. It is brought from Askeaton. The wages of farm servants yearly - males, £4 to £5; females, £2. Labourers' wages - 8d. per day in summer; 6d. per day in winter.

This townland is situated in the S.W. side of the parish. It is bounded on the N. by Park and Moyreen tds.; W. by Kilmoylan ph.; S. by Knockfinnisk td.; and E. by the phs. of Rathronan and Kilcolman.

It contains 691 $\frac{1}{2}$  acres. The proprietor is Francis L. Lloyd, Esq. Limerick; held under lease, rent bulked at £55 16s. 6d. per annum. This td. is under the Courts, agent Wm. Browne, Esq. Ballingarry. Co. Cess paid for 12 $\frac{1}{2}$  acres half yearly at 2s. per acre. Soil not good, a great part bog. Produces poor crops of oats and potatoes.

This is a central townland. It is bounded on the N. by Kilmoylan ph.; W. by the tds. of Moneymohill, Cortadroma and Park; S. by Kilcolman ph.; and E. by the td. of Dooncaha.

It contains 475 acres. The proprietor is Lord Clare, Mount Shannon, Limerick. All held under one lease; rent bulked at £55 7s. 8d. yearly. Farms from 30 to 91 acres, including bog. Soil not good. Co. Cess paid for 150 acres, at 2s. per acre half-yearly. Light crops of oats and potatoes with a little flax. There are some paupers here, having only 1 acre.

It contains 611 acres. The proprietor is Lord Clare, Limerick. It is held under different leases from 8 shillings to £2 10s. per acre. Farms from 10 to 60 acres. Co. Cess

It contains 433 acres. Proprietor is Lord Clare, Limerick. Held under different leases from £1 11s. 6d. to £3 10s. per acre. Farms from 6 to 60 acres. Co. Cess 2s. 0½d. per acre for 182 acres half yearly. Soil good, producing wheat, oats, potatoes, and some flax. There is an old church in ruins in this townland.

It contains 385 acres. The proprietor is the Representative of the late Stephen Dixon, Limerick. Agent, Dixon Power, Esq., of Kilfinnane, Limerick. Held under lease by Christopher Delmege, Esq., Castlepark, Limerick, who sublets for £105 yearly. Co. Cess 1s. 0½d. per acre. Farms from 5 to 8 acres. John Motgan, Esq., of Park, is proprietor of part of this townland. Crops of potatoes and oats middling. In this td. are an old castle and a graveyard.

Soil, mostly heathy mountain, with only a small part arable at the Glens, attached to houses, producing poor crops of oats and potatoes.

It contains 370½ acres. The proprietor is the Knight of Kerry, near Listowel. Agent, Stephen Edward Collis, Esq., Listowel. Held under lease; rent £1 18s. per acre. Farms, from 9 to 54 acres. Co. Cess 2s. 2d. per acre half yearly. Soil good, producing potatoes, oats and some wheat. (N.B. Co Cess is paid only for each of 100 acres.)

Situated in the N.W. portion of the County of Limerick and Barony of Shanid, and divided into 3 portions, of which two are situated to the East and one to the West.

Of the two eastern portions, the extreme eastern portion is bounded on the North, East and West by the ph. of Lismakeery, and on the S. by Kilbradran ph. The other eastern portion is bounded on the North and East by Lismakeery ph., on the South by Kilbradran ph., and on the W. by the phs. of Kilbradran and Kilmoylan.

It is the property of General Dickson, England. Agent, Samuel Power, Esq., Limerick, who lets it to 3 tenants, 2 of whom are at will and 1 holds by lease and sublets to 4 tenants at will. Rent per acre from £1 5s. to £1 10s. Co. Cess per acre yearly from 3s. to 5s.8d. Tithe per acre, 2s. Size of farms, from 25 to 50 acres. Soil light, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names - Maddigan and Hurley. There is one ancient fort here.

This townland is situated in an eastern portion of the parish. It contains 241 acres. There are five ancient forts here.

It is the property of John Croker, Esq., Ballyneguard, Limerick, and is let to Samuel Johnson, Esq., on a lease for ever, who occupies a part and sublets the remainder to 19 tenants, 7 of whom have leases and 12 at will; rent per acre from £1 to £1 10s. Co. Cess per acre yearly from 3s.6d. to 4s.6d. Tithe per acre from 1s.6d. to 2s. Size of farms from  $\frac{1}{2}$  acre to 28 acres. Soil light, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names - Condon and Johnson. This td. is watered by a stream containing trout and eels.
