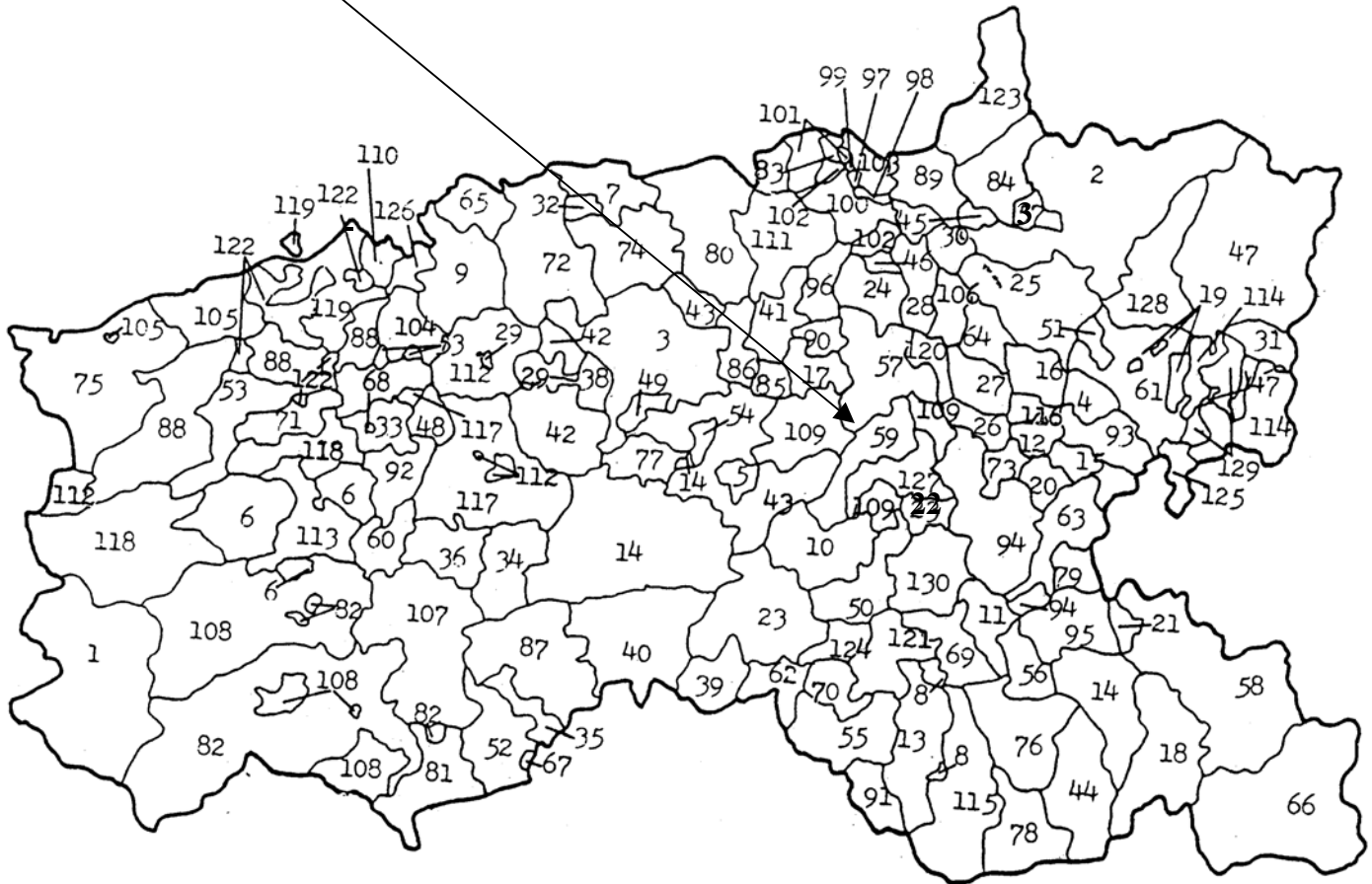

It contains 4,252 acres, statute measure, and is situated about 5 miles N.W. from Bruff, on the road to Croom. The seats of Cahir Guillamore and Rockbarton are in this parish. Five small glebes belong to the parish, comprising together 29½ acres; they were originally the endowments of chantries connected with the abbey church founded here by the De Lacys.

Is the property of the Revd. Mr. Dixon, Carrigogunnell, and contains 733 acres, including about 250 acres of arable land, with the remainder rough pasture.

The property of Lord Limerick, England, containing 777 acres, including about 100 acres of rough ground with the remainder arable land. In the W. of the townland is Crean Burial-ground. There are 3 ancient forts, one in the W., one in the E., and the third in the S. of the townland.

The property of General Dixon, England, containing 196 acres, including about 95 acres of demesne, and the remainder arable land. On the S. boundary of this townland with Monasteranenagh Ph. is Grays Bridge. In the S. of the td. are a Roman Catholic Chapel, Greenlawn House, and a Trigl. Station named Meanus in Tree.

was occupied by a band of rogues and robbers, from which Glenogra is imagined to take its name at the present day. Great skill was displayed in the erection of these now ruined walls and archways, which now lead for about 60 or 100 yards in the direction of Fedamore.
