

A gentleman who left London but last Thursday evening informs us, that it was currently reported there, and generally believed, that the Earl of Salisbury would be shortly appointed Lord Lieutenant of this kingdom, in the room of his grace the Duke of Rutland.

Should such an event take place, Lord Killwarlin, who is brother-in-law to the Earl of Salisbury, is to be appointed his principal secretary, a circumstance which will add considerably to the Hillsborough interest.

Yesterday came on in the court of King's bench the trial of Thomas Heney, an outlaw, who had absconded to elude public justice, on a charge of being concerned some years ago in the most inhuman and wanton murder committed on Ambrose Power, Esq; (brother of the Hon. Mr. Baron Power). The trial and enquiry for the verdict of the jury was, whether Heney was the same person that the outlawry was issued against; which being fully proved by various evidences, the jury found Heney GUILTY, but the Court did not pass any sentence on him, he having by law 4 days before final sentence can be awarded against him.

The trial and execution of the unfortunate Fitzgerald, are as honourable to the administration of justice among us, as the condemnation and punishment of the late Lord Ferrers were deemed by foreigners to British government. In the scale of found morals, the crimes of men elevated by station and abilities are more heinous and inexcusable in their nature, than those of their inferiors; and the end of just punishments, viz. the prevention of the same offences, is more effectually answered by the rigorous infliction of them on such distinguished offenders. The humanity and wisdom of the Court were eminently displayed on the late occasion. No expression or mark of that repentment, which to enormous a crime might naturally have excited, occurred; every step was taken to bring the assailants of the prisoner to justice, and the fairest attention was paid to every thing which he or his counsel could produce in his favour. This unfortunate and distinguished victim to offended justice, will proclaim thro' the kingdom, that no opulence, talents, or influence can protect a man who dares to violate the laws. The good citizen will, at the same time, feel his love to his country increased by reflecting on the equal distribution of justice among us; the security of the weakest subject against the most powerful; and the admirable provision by the TRIAL BY JURY for the protection of the innocent individual against even the collected vengeance of government itself. He will remember, according to an eminent foreigner, "that it can be said of these kingdoms only, that NO MAN EVER MEETS THE MAN of whom he may say— THAT MAN HAS A POWER TO DECIDE ON MY DEATH OR LIFE."

Though the Hervey family have long been remarked for a certain levity of conduct, yet there is no part of their character more unaccountable than certain flashes of bravery and cowardice, which have at times elevated and debased them in the public mind. The late Lord Bristol was the first who

had thought it necessary, without assigning any reason. But after his conviction he spoke in terms of high respect of the gentlemen who formed the jury by whom he was tried. The Attorney General also with great humanity gave Fitzgerald and his counsel every advantage and opportunity that they could possibly wish, and more than they could have reasonably expected.

### C O R K, June 19.

Last Tuesday night about ten o'clock, Thomas Barry, a Bumbailiff of this city, accompanied by his wife and a Mrs. Lyne, Publican, went to a place called the Old Barrack, in Cockpit-lane, in order to execute a warrant for an assault in which Mrs. Lyne was Plaintiff, issued against Timothy Sullivan, Coal-porter; when the women saw Sullivan they immediately ran at him and seized him by the hair, by which they held him, whilst Barry, with a barbarity that would disgrace a savage, made several stabs with a drawn bayonet at Sullivan, one of which entering near the left breast, proved mortal, and occasioned his death, on Friday morning at 4 o'clock, Mr. Rowland Sharp peace officer, apprehended Barry and the women, whom he committed to Bridewell, until the Inquest sat upon the body, when they brought in a verdict wilful murder, against Thomas Barry, his wife, and Johanna Lyne; the three were then transmitted by said Sharp to the North Gaol.
