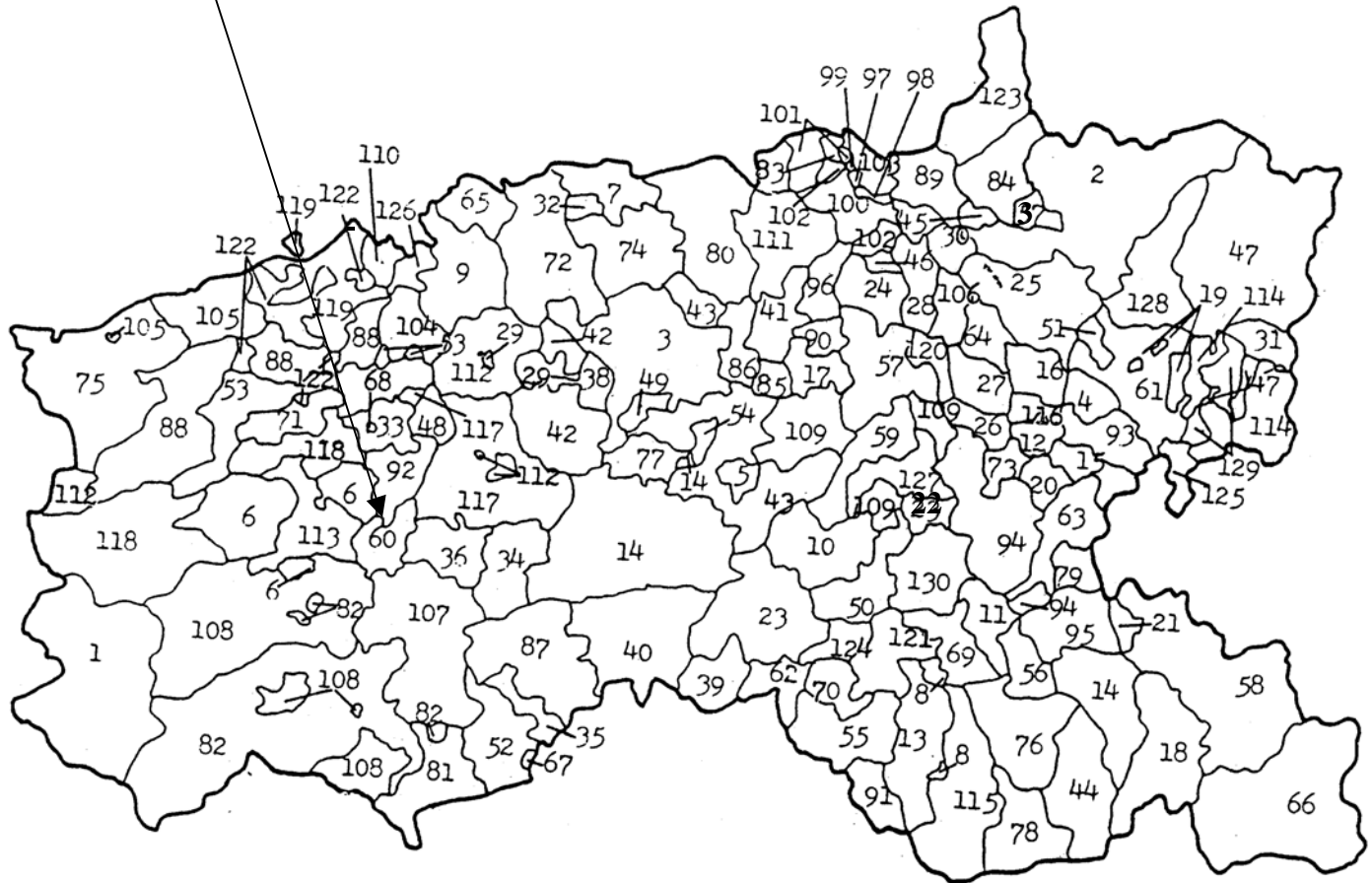

Its N.E. point is situated about 5 miles S.S.W. of the town of Rathkeale, and its S.W. point is in the suburbs of Newcastle Town. It is bounded on the N. by Kilsannel Ph.; E. by Rathkeale Ph. and Clonelty Ph.; S. by Mahoonagh Ph.; and W. by Monagay Ph.

It contains 2,838 statute acres, and is all tillage and arable. It is the property of sundry gentlemen. The Mail Coach Road from Newcastle to Rathkeale passes through its western extremity. The River Deel passes nearly through its centre from S. to N., and the road from Newcastle to Knockaderry Village also passes through it. On this road, at the eastern extremity of the parish, is Chesterfield House, with a garden, orchard, plantation and fishpond. The rivers Arra and Hehernagh form part of its southern and western boundaries.

This townland contains 216 acres, and is the property of the Earl of Devon. It is all under cultivation. The Mail Coach Road from Newcastle to Rathkeale passes northward, and the road to Knockaderry passes eastward, through the townland. There are 4 ~~four~~ts here. Acreable rent - £2.

This townland, which is also called Chesterfield, contains 127 acres, and is the property of James Sullivan, Esq. The road from Newcastle Town to Knockaderry Village passes on its southern extremity. North of this road stands Chesterfield House with a garden, orchard, plantation and fish pond. There is another road on the boundary of this townland with Evegallahoo Td.

This townland contains 102 acres, and is the property of the Earl of Devon. All arable land. The River Deel forms the east boundary, and the Rivers Arra and Hehernagh form the greater part of the western boundary, of the td. The Mail Car Road from Newcastle to Drumcullagher also forms part of its southern boundary, and N.E. of this road stands a large fort. Acreable rent - £2.

In the west part of the parish, about $\frac{1}{4}$ mile N.N.E. of Newcastle Town. Bounded on the N. by Ballingowan Td.; E. by Gortroe Td.; S. by Gortboy Td.; and W. by Ardagh Parish.

This townland contains 207 acres, and is the property of the Earl of Devon. It is all under arable and tillage. The Mail Coach Road from Newcastle to Rathkeale forms its eastern boundary, on which there is a Turnpike; and N.E. of the Turnpike, and about 30 links west of the road, is a large tree called Crannacrohy, or Gallows Tree, where some people are said to have been executed. The River Daar forms the southern boundary of the townland. Acreable rent - £2.

In the south part of the parish, a short distance E. of Newcastle Town. Bounded on the W. by Gortboy Td.; N. by Gortroe Td.; E. by Arddrine Td.; and S. by Mahoonagh Td. and Cloonyscrehane Td..

This townland contains 378 acres, all arable land. It is the property of the Earl of Devon. There is a bye road through it. In the west end is Drummin House with gardens and orchard. The River Daar forms part of its south boundary and, running through this townland, joins the River Deel, from which point the R. Deel forms the S. and E. boundary of the townland. There is a large fort on the S. boundary between Gortroe and Drummin Deel, and there are 2 smaller forts within it. Acreable rent - £1 19s.

In the N.N.E. part of the parish, about 4 miles S.W. of Rathkeale Ph. Bounded on the W. by Ballymorrisheen Td.; N. and E. by Rathkeale Ph.; and S. by Carrowgar and Grange Lower Tds.

This townland contains 212 acres, all arable. It is the property of James D. Evans, Esq. The River Deel forms its western boundary, and floods to a considerable extent. There is also a bye-road in its southern extremity. Acreable rent - £1 17s.

The Mail Coach Road from Newcastle to Rathkeale forms its western boundary, and on it is a turnpike. The River Daar forms part of its southern boundary. There is a fort in its N.E. extremity. Acreable Rent - £2.

This townland is the property of the Earl of Devon, and contains 121 acres. It is under tillage, and the road from Newcastle to Knockaderry Village passes through its northern extremity. On this road is Grange Bridge over the River Deel, which forms the east boundary of this
