

the remarkable actor in the time of William the Third, after being killed in a frivolous quarrel, at the Royal-tavern London, is said, by an author of that time to possess a person so remarkably handsome, that after he was killed, several ladies, very well dressed, came to visit him in his shroud. But a more extraordinary instance than any of these is given by Captain Peter Bruce, who accompanied Peter the First, and his Empress Catherine, to the borders of Persia, on the conquest of all the surrounding Tartar nations. "Our way through Dagestan (says Bruce) was most delightful, sixteen miles of gardens and vineyards in a stretch. The Dagestans opposed us on the heights, and seemed determined to defend their liberties. On the first day we killed 300 of those who came forward with pikes; on the second 200. In the slaughter of this day were men so handsome, and particularly one youth, that the Russian troops made a halt to gaze upon his beauty; by which they were so moved, that if the Emperor had not shot the leading officer, the army would not have gone on.—What form and features must that corpse possess, which retarded the progress of a Russian army!"

The 5th inst. died in London, of an apoplexy, in an advanced age, the Right Hon. Lady Elizabeth Villiers. She was daughter and sole heir to the Right Hon. John Villiers, Lord Viscount Purbeck, who succeeded to the titles of Earl Buckingham, Viscount Villiers, Baron of Whaddon, on the death of George Villiers, Duke of Buckingham in 1687; King William, in December 1699, exemplified those titles under the Great Seal of England. His Lordship died August 10, 1723, leaving one daughter, his heir, Lady Elizabeth Villiers, by whose death the noble family of the Villiers, of the Buckingham line, is extinct.
