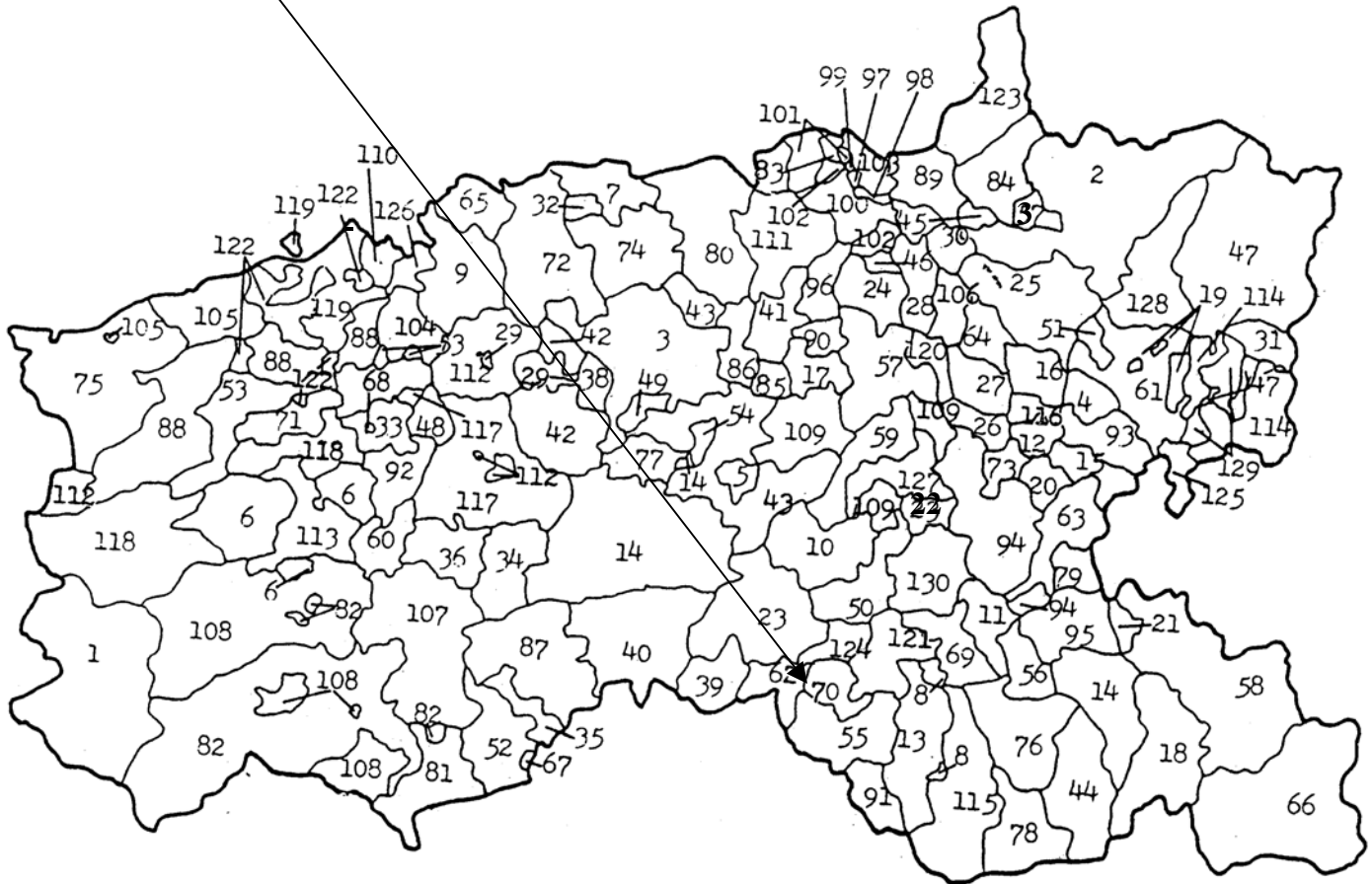

This parish is bounded on the N. by the Ph. of Tankards-town; W. by Hackmys Ph.; S. by Effin Ph.; and E. by the Ph. of Saints Peter and Paul. Contains 2,110 acres.

The soil is aggregately good, but only about one-fifth is under tillage, the remainder being meadow or pasture land. Near the S. bank of the Subtach are the ruins of the old church. The parishioners, about 600 in number, are all Roman Catholics.

In the N.W. extremity of the parish. Bounded on the N. by the Ph. of Tankardstown; W. by Hackmys Ph.; S. by the Td. of Mount Blakeney; and E. by Kilbreedy Td.

The property of Mr. Nesbitt, an officer in the 10th Regiment, and contains 178 $\frac{1}{2}$ acres.

In the N. extremity of the parish. Bounded on the N. by the Ph. of Tankardstown; E. by the Ph. of St. Peter and St. Paul; S. by the Td. of Thomastown; and W. by the Tds. of Mount Blakeney and Cloonlogue.

The property of Mr. Nesbitt, an Officer, and contains 351 $\frac{1}{2}$ acres of arable land. About the centre of this townland are a graveyard and a church (in ruins) called Kilbreedy Church.

In the S.W. extremity of the parish. Bounded on the N. by Cloonlogue Td.; E. by the Tds. of Kilbreedy and Thomastown; S. by the Ph. of Effin; and W. by the Ph. of Hackmys.

The property of Lady Fitzgerald of Cork, containing 562 $\frac{1}{2}$ acres. In this townland are 3 ancient forts, two of which are in the eastern part, and the third in the central part, of the td. In the S.W. part there is also a Trigl. Station, called Mount Blakeney Cong.

In the S. extremity of the parish. Bounded on the N. by Kilbreedy Td.; W. by the Td. of Mount Blakeney; S. by the Ph. of Effin; and E. by the Ph. of St. Peter and Paul and the Td. of Tobernea.

The property of Captain Saunders of Charleville, containing 952½ acres of arable land. In this townland are 4 ancient forts, one near the N.E. boundary, another in the S.E. part, a third in the S. part, and the fourth in the W. part, of the townland.
