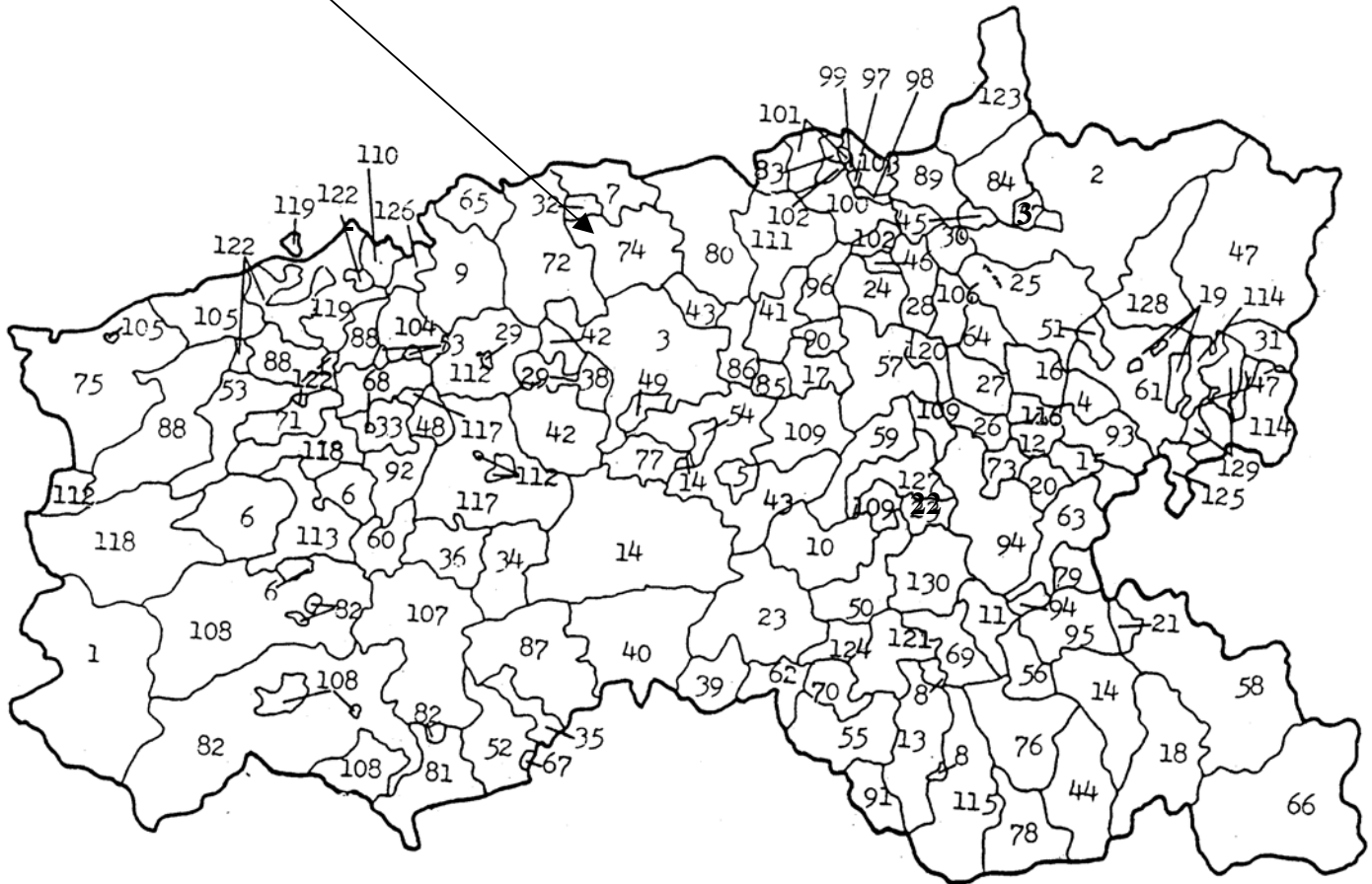

It is of a rectangular form. Its greatest length from Ardlahan Td. in the N. to Monanooag Td. in the S. is 3½ miles; and its breadth from the junction of the Tds. of Glenameade and Tobermurry with Ballyshonickbane Td. in Kilcormán Ph. in the West to the Td. of Faha in the East is 4 miles.

Co. Cess per acre yearly 2s.6d. Tithe 18d. to 2s. per acre. Soil gravelly, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names - Walsh and Sheehan. There is a school here, containing 36 boys, 31 Protestant, 5 Catholic. It is supported by the Bishop and Revd. Wm. Waller. Tobermurry Holy Well is situated here. There are stations occasionally performed at it by the peasantry.

The ruins of this castle stand in a rectangular space of about 132 ft. long and 120 ft. broad, inclosed by a wall of about 30 ft. high. Fragments of the castle walls are standing, and 3 chimneys remain, which are about 50 ft. high. At each angle of the courtyard and outside stands a square tower, 2 stories high and arched overhead. The apartments in the towers are about 7 ft. square.

It is a rectangular building, 28 ft. long and 22 ft. broad. The north wall is tolerably perfect, and a fragment of the east wall remains; the remainder is razed to the ground. The lower story was arched and the upper two were

lofted, which is evident by hewn stones jutting out and holes placed at regular distances in the north wall. The ascent to the top was by a spiral staircase, which still remains.

Cullam Castle ruins -- Local 33

Cullom, gd. Coll Lom, bare hazel - (if it be not this, the name is English.) J. O'D.

Cullam Castle ruins -- J. O'D.

Cullum Castle ruins -- Barony Map

Situated in Court Td., within 2 chains of the west bank of the R. Maigue.

This old castle is about 32 feet square, and is at present called the Pigeon House by the Inhabitants. Its height may be about 24 ft. at present; but it appears to have formerly been higher. Two chains to the west of it stand the ruins of Court House, which was inhabited by the Hasting Family.

Bolaan Castle ruin -- John Hayes, a tenant 34

See name of townland. O'D.

Situated in Bolane Td.

This castle is built upon a limestone rock, and is a rectangular building, 30 ft. long and 20 ft. broad. The south wall is perfect. The north wall is entirely down, and only fragments of the other walls remain. The different stories of this castle were arched. Its height may be about 80 feet.

Killolatha Church ruins -- Michl. Mead, Glenamead. 35

Cill Ultach, church of the Ultonians.

Killulta -- J. O'D.

Situated in the N.E. portion of Glennamead Td.

These ruins are 20 ft. long by 14 ft. broad on the outside, and 15 ft. long by 9 ft. broad inside. The walls are tolerably perfect. There is a window on the East about 15 inches high and 8 inches broad on the outside, widening inside to a height of 4 ft. and a breadth of 2 ft. The height of the side-walls is about 9 ft. According to the historian Ferrar, this church was founded by the pious Dioma.

Tubbermurry Holy Well -- Danl. Cronan, Tobermurry 36

Tobar Muire, the Virgin Mary's Well.

Tobermurry &c. -- J. O'D.

Situated in a marsh in the south of Tobermurry Td.

Stations are performed here occasionally.

Phereagh Lough -- Local 37

Fiodh Riach, grey wood.

Feereagh -- J. O'D.

Situated in the south of Glennamead Td.

On the north of the new line of road connecting Askeaton and Limerick. This is as much a marsh as a lough, and is called the Blind Lough occasionally. It contains about 5½ statute acres.

Blind Lough -- Local 38
-- J. O'D.

Situated in the S. of Glennamead Td., on the parish boundary between Kildimo and Kilcornan.

This is as much a marsh as a lough. It contains about 8 statute acres.

Kilbreedy Lough -- Local 39

Ballashea Lough -- Barony Map.

See Parish of Kilcornan for description.

River Maigue -- B.S.S.M. 40

An Mháig, also Abhainn Máighe, river of the plain.

River Mague -- Barony Map

Situated on the east boundary of the Ph. of Kildimo, separating it from the Ph. of Kilkeedy.

Kildimo New Village -- Local 41

See name of parish. J. O'D.

Situated in the west of Ballyvareen Td.

This village contains 32 houses, a police station with 1 sergeant and 4 subconstables, 4 publicans, 1 baker, a smith, 2 shoemakers and 2 carpenters.

Kildimo Old Village -- John Fitzgerald 42

Situated partly in Kildimo Td., and partly in Ballyrune Td.

This village contains 21 houses, 1 publican, 4 hucksters, 1 smith, 4 shoemakers, 1 weaver, 1 carpenter, and 3 taylors. There is a R. C. Chapel here, and a school containing 60 boys and 30 girls, all R. Cs.

Kildimo R. C. Chapel -- John Fitzgerald, Kildimo 43
 -- J. O'D.

Situated in Kildimo Td.

This chapel was repaired and roofed in 1836. It can accomodate 500 persons.

Kildimo Church -- Local 44
 -- J. O'D.

Situated in the Glebe of Kildimo.

A small commodious church, capable of accomodating about 100 persons. It lies about 1 furlong to the S. of the Glebe House. "The ancient church of this parish was founded by the pious Dima". Ferrar's History of Limerick.

 Court Bridge -- Barony Map

Situated on the boundary between the parishes of Kildimo and Kilkeedy.

This bridge crosses the River Maigue at the new line of road connecting Limerick and Askeaton, between the townlands of Cloghatacka and Court. It is a draw-bridge, and boats passing through it pay 3s. toll.
