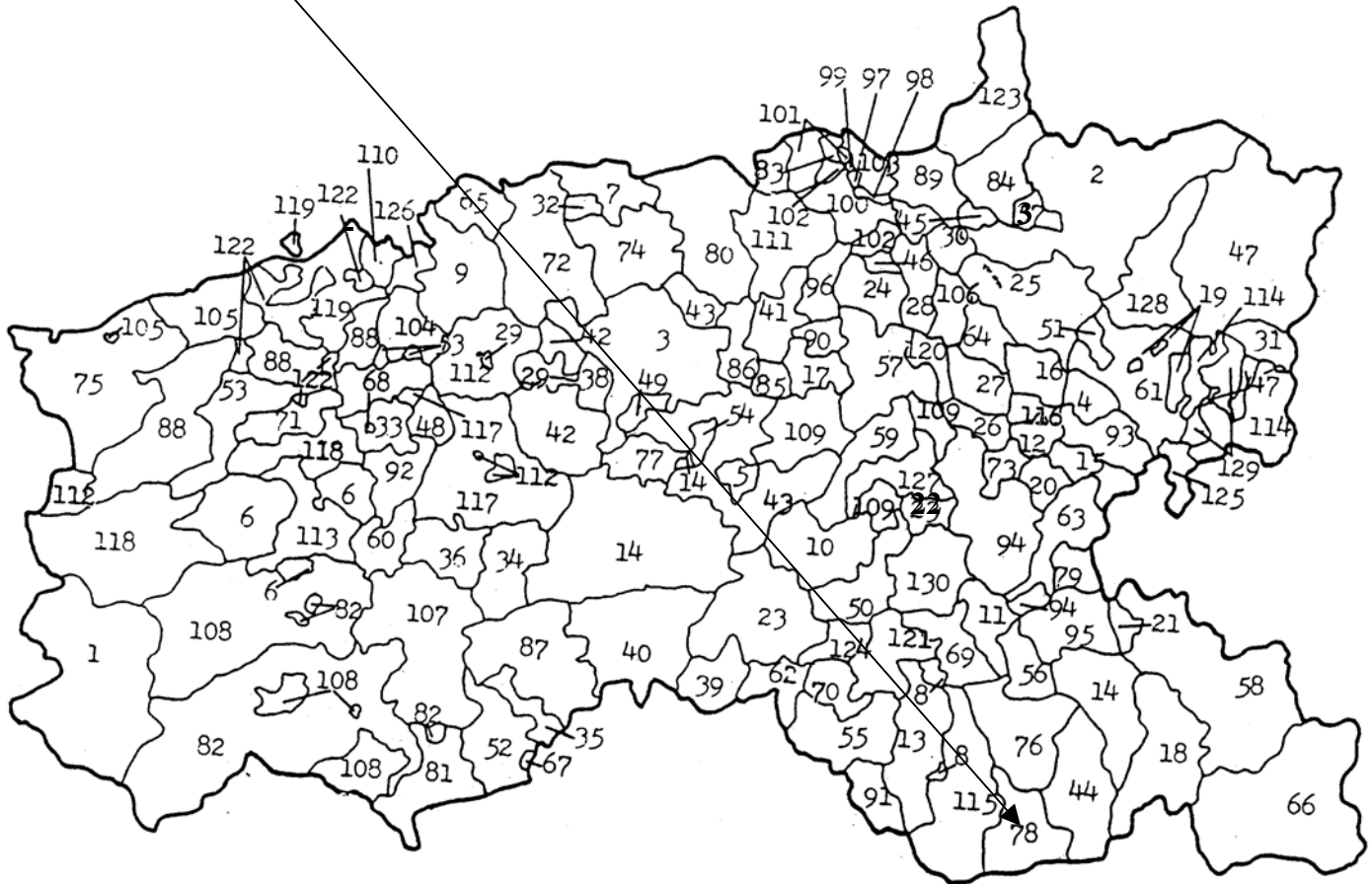

Bounded on the N. by Kilfinnan Ph.; W. by Particles Ph.; E. by Darragh Ph.; and S. by Kildorrery Ph. in the County of Cork.

Contains 4,819 acres, statute measure. One-third is a mountain of a boggy nature, lying part south of the parish; the remainder is arable land and lies N. of the parish. There are several roads in all directions through the ph. There is a good village, called Ballyorgan, in the N. of the parish and S. of Ballyorgan Td. The ruins of an old abbey stand in Abbey Td. The highest part of the parish is S. of Coolfree, 1427 feet above the sea.

In the N. of the parish. Bounded on the N. by Ballinlyna Upper Td.; W. by Ballydonohoe Td.; E. by Reale Td.; and S. by Kileruaig.

Is the property of Oliver C. Oliver, Esq., Castle Island, Co. Cork. It contains 223 acres, all arable land with the exception of 2 small portions of rough pasturage, one in the N., the other in the S., of the td. In the N. there is an ancient fort. About the centre is a road, bearing E. and W. S. of the road, close to the E. boundary, stand the ruins of an old abbey. There is one Trigl. Station on the N. boundary, 607 feet above the sea level.

In the W. of the parish. Bounded on the N. by Clovers Td.; W. by the Tds. of Raheenroe and Castle Oliver; E. by Ballydonohoe Td., and S. by Coolfree Td.

Is the property of Gascoigne Oliver, Esq., England, & contains 356 acres, all arable land with the exception of a small portion of rough pasturage along the S. boundary. The large village of Ballyorgan lies on each side of a road bearing directly N. and S. through the centre of the td. E. of the road, close to the village, is a R. C. Chapel. In the S.E. of the td. there is a Church.

In the N. of the parish. Bounded on the N. by the Td. of Ballinlyne Upr.; W. by Ballyorgan Td.; E. by Abbey Td. and S. by the Tds. of Coolavehy and Houndscourt.

Is the property of Gascoigne Oliver, Esq., England. It contains 208 acres. In the N. of the td. there is a portion of rough pasturage; the remainder is arable land. One road crosses the td., about the centre, bearing E. & W. In the S. of the td., close to the boundary of Ballyorgan, Coolfree & Houndscourt, there is a Tuck Mill. The west boundary is the centre of a road, on both sides of which are several neat houses.

Clovers (contd.)

It contains 309 acres, all arable land with the exception of 2 small portions of rough pasturage in the S.E. There are 2 ancient forts, one about the centre, the other in the N., of the td. There is a large gravel pit close to the N.W. boundary. In the S. of the td. there is a cross-roads (one bearing S., the other E. and W. in a curving manner).

In the S. of the parish. Bounded on the N. by Ballydonohoe Td.; W. by Hounds court Td.; E. by Kilcrusaig Td.; and S. by Moanbeg and Ballyvisteen Tds.

Is the property of Gascoigne Oliver, Esq., England. It contains 569½ acres, statute measure. Half is arable land; the other half is a mountain of a boggy nature, and lies in the S.W. and N.E. of the td., the arable land being in the centre. One road bears N.W. and S.E. through the arable portion, and has several neat houses on both sides of it. There are several car tracks through the mountain in the S.W.

In the S.W. of the parish. Bounded on the N. by Ballyorgan Td.; W. by the Tds. of Glenosheen and Glenanair (Ph. of Particles); E. by Hounds court Td.; and S. by the Tds. of Moanmore, Farihy and Moanbeg.

Is the property of Gascoigne Oliver, Esq., England. It contains 992 st. acres. One-third of the td. is arable land; the remainder is a mountain of a boggy nature. In the N. of the td. there is a cross of 3 roads, one bearing directly N., the other E. and W. in a curving direction. Near the road and near the ruins of an old house is a well. About the centre of the td. is a Trigl. Station, Coolfree, 1427 feet above the sea level.

In the S.E. of the parish. Bounded on the E. by the Tds. of Ballynacourty and Keale; W. by Kilcruaig Td.; E. by Darraghmore Td.; and S. by Graigue Td.

Is the property of Gascoigne Oliver, Esq., England, and contains 625½ acres. One-third is a mountain, South of the td.; the remainder is arable land. One road bears E. and W. across the td. In the N. of the td., close to the boundary of Keale Td., there is a portion planted with trees. There is another small portion under trees near the centre of the td. A few houses are interspersed throughout the td.

Towards the N. there is a neat house, with offices and a few trees planted round it. In the S. of the Td. is Coolfree Connecting Point, 1313 feet above the sea level.

Is the property of Gascoigne Oliver, Esq., England. It contains 565 $\frac{1}{2}$ acres. One-third is mountain of a boggy nature, S.E. of the td.; the remainder is arable land. One road bears from the S.E. boundary towards the N. to the centre of the td., then turns E. in a curving manner. In the W. of the td. and to the W. of the road, there are two small moats near to each other. Adjacent to the N. boundary there is a portion under trees.

In the S. of the td., adjacent to the boundary, there is a small portion under wood.
