## COUNTRY NEWS.

Waterford, Aug. 11. Last Sunday the White Boys affembled at Carrick, and Iwore feveral people in and about that town.

Last Tuelday there was a numerous and re fpectable meeting of the nobility, gentry, clergy, and freeholders of the county of Waterford, at Dungarvan, convened by Sir Richard Mulgrave, Sheriff; when they unanimoully came to feveral spirited resolutions for the suppression of tumultuous rikings and proceedings of those infatuated people called White Boys.

Last Tuesday died in Factory lane, the relict of John Edgworth, Efq; formerly one of the land-waiters of this port.

Clonmel, August 10. A friend to humanity, who lately observed a number of decent tradesmen, unemployed in this town, was induced to enquire to what saule their want of employment was owing, he found them to be journeymen combers, whom their employers had difbanded; and, on applying to the mafters, he was given to understand, that the extraordinary advance in the price of wool had rendered it impossible for them to continue the business without a certain and confiderable lofs;-to support this affertion, the mafters affured him that they had on hand worsted to the amount of many thousand pounds which they could not wend, at a price that would bear any propertio nto that which the raw material fells for at prefent.

On further enquiry he found that no lefs a number, than eighty combers have been lately turned out of work, who, if fully employed would in the courfe of twelve months, work up the produce of twenty five thousand stones of fleece wool; the labour of manufacturing which would amount to eight thouland pounds -These circumstances he was affured were, (and believe to be) facts, and also that if the present high prices of wool continue, there must neceffarily be many more tradefmen put away.

He fubmits it to the confideration of the gentlemen of the town and neighbourhood of Clonmel, whether it be not well-worth their attengion to ftrike out fome employment for the many hands which were employed in this ufeful branch of bufinefs, who are now idle, and confequently in want. The town must be materially interested in such a measure; the decay of trade in any place foon becomes visible in the decline of the place itself, and Clonmel must certainly seel the effects of the present so remedy the evil.

We hear from Allolas, in the county of Clare, that a man named Paul O'Brien died lately here, aged 107 years five months. This patriarch of the weltern perfantry, as he might be called, exercifed the trade of a conper, in which employment, he rambled all over the country, until within a few days before his death.

It is much to be lamented that after all the exertions of the Mayor, to have the inhabitants supplied with pure and wholesome bread, there is still a great quantity of musty bread manufactured in town, which the Mayor has given first orders to be seized and given
