Workers' Union has taken place with regard to farm labour. The question of wages has been raised, with reference to which the disputes affect small areas and individual owners, who in most cases have been able to effect a fair settlement; and in the second place objection is taken to labour by non-union men. Men in different districts are giving notice of their intention to stop work at a critical period of the harvest, on the ground that they cannot work with men who are not members of the union. This simply means the application of trades union methods to agriculture, and employers of farm labour find it difficult to grapple with the situation thus created. The action of the union in this matter, which so seriously affects the prosperity of the country, is hindering the progress of labour in the counties of Kildare, Dublin, Louth, and elsewhere, and leaving the harvest in a state of uncertainty. In Ulster a large number of men have left their work, mainly in connexion with the flax industry for the same reason. They also claim that they should be paid for ordinary farm work at the same rate as Mr Andrews' Commission fixed for flax pulling, although the two branches of industry are entirely different, and the same rule does not apply to both. The disputes appear to be mainly confined to the midland and northern counties.

SUDDEN DEATH IN THE CITY.

The death took place suddenly in Catherine-street yesterday of Mr Richard Ryan, farmer, Cross, Pallasglean. The deceased, who was in his eightieth year, arrived in the city to transact business by an early train, and was returning to the railway station in the evening when he took ill in Catherine-street, and died in a few minutes. He was attended to by a man named Hannan, who brought a clergyman, and word was also conveyed to William Street Police Station. The remains were subsequently removed to Barrington's Hospital, and an inquest was held in the City Courthouse to-day by Mr J F Barry, J.P. Coroner, and a jury, of which Mr P Geary was

However much the Nationalist factions hate each other, they will bury the hatchet for the time being rather than see such seats as West Belfast, South Down, or East Tyrone going to the Unionists.
