cannot be justified on any pretext whatsoever. If they think themselves aggrieved, they ought to remonstrate to their superiors, whose inclination as well as duty it is, to hear them patiently, and relieve them effectually, in case their complaints are well grounded. But if, instead of applying to the justice and humanity of their rulers, they shall obstinately persevere in their fruitless endeavours to intimidate them, by tumultuous meetings, by tendering unjust oaths, and other unlawful proceedings, they may be assured, that, in place of obtaining redress, they will experience the indignation of Heaven, the censure of the church and the extreme rigour of violated laws. Such weak, deluded or wicked persons of our communion as have entered into this execrable combination, have sinned by taking it forcibly or freely, will sin still more heinously by observing it. This is the inviolable doctrine of the church. This has been our constant language, whenever a spirit of combination prevailed amongst WHITE-BOYS, tradesmen, or any other class of our people. We conjure you most earnestly to desist from disturbing the public peace, and scandalising your holy religion, and her ministers, by despising their admonitions; which, if duly attended to will promote the good of society in general, and the particular happiness of every one among you, in this and the next life, which are the constant objects of our fervent wishes and prayers.

Cork, Aug. 21. Last Saturday night, a Brewer-Man belonging to Mr. Proby, of this city, from the darkness of the night missed his way, and fell into the river below Parliament bridge, and was unfortunately drowned.

Public indignation against the lawless proceedings of the White Boys every day increases; and a firm and determined spirit of opposition to them should pervade every order of peaceable and well disposed people.

Many persons having been misled into an opinion, that the proceedings of the White Boys are not punishable by law, such persons are requested to peruse, with attention, extracts from an act of Parliament to prevent tumultuous risings, passed last session, whereby it appears that many of their acts are made felony without benefit of Clergy; and that any Justice of the Peace, or other Peace Officer, and the military when called to their assistance, will be justified in killing or maiming such persons as shall unlawfully assemble under any assumed name or title, or commit any unlawful act mentioned therein.

Waterford, August 22. Last Sunday the Right Boys visited the parishes of Newcastle and Kilmeaden, in this county, and swore the inhabitants to abide by their laws. They did not appear at Portlaw, as was given out.

The Right Hon. the Earl of Tyrone, and several active magistrates in the county of Waterford, are taking every proper, legal step, to suppress the unlawful assembling of those insatuated people called Right Boys.

cloaths, and declared if they moved but as he did, they should be instantly shot; he then formed a circle, or hollow square with his six men round the prisoners, and kept up a continual fire of one shot at a time, moving on as well his situation would permit him, and with great difficulty got to the house of Major Dumais, at Coolroe, about two miles from the place where the action commenced, and nearer Cork. Unluckily the Major was from home; but Mrs. Dumais rendered the corporal and his party every assistance, by letting them into the house to defend themselves from the assailants, and kindly procured a trusty messenger to carry a note from the corporal to Mr. Hawkes, the neighbouring Justice, who instantly came, and by his spirited exertions, prevented any further attack; until a company of men marched from this city, who safely conducted the prisoners to goal.

"The numbers of the killed and wounded are not yet particularly known, report says, nine killed and thirty wounded, and we have great reason to believe it may be true, as there were seventy-two shots discharged, and the situation of the regulars obliged them to fire deliberately and with effect. The manoeuvres of our Gallant Corporal is truly praise-worthy; we are happy to hear, that neither he or his little army suffered much in this affray, except a few contusions from some of the stones, but no way dangerous."
