It is extraordinary that when his friends lighted Mr. Doker to the lower landing, he could possibly be supposed to fall out of a window. It is not at least probable. It is equally amazing, that if he was attacked by an assassin at the front door, that even the effects of anger and violence did not convey an alarm in the very committing of the fatal deed.—The conduct of Hurley and wife's testimony is equally inexplicable; and the ignorance of the surrounding centinels, each within hearing of every noise, form altogether a scene of mystery which time alone can explain.

Mr. Doker was a very fine young fellow, well esteemed in the regiment, and respected by all who knew him.

Their first attack was on the house of Thos Mason, Parish Clerk of Fedamore, against whom their fury is particularly pointed, and not finding him at home, 6 poor children one of them on the breast, could not protect their mother, his wife, from their rage, as they struck her with the butt end of a pistol and knocked her down, afterwards they broke in the doors of several other houses in search of persons, and administered oaths where ever they went.—Surely those and such other acts of unexampled violence and barbarity should, ere it is too late, rouse Government and the Gentlemen of the Country (without whose co-operations nothing can be done) to unite in such exertions as may speedily restore peace and good order to this distracted country, where tumults riot and every species of warring and cruelty have arrived to such an alarming pitch, that the peaceable inhabitants are afraid to lie in their beds by night or to travel the roads by day.
