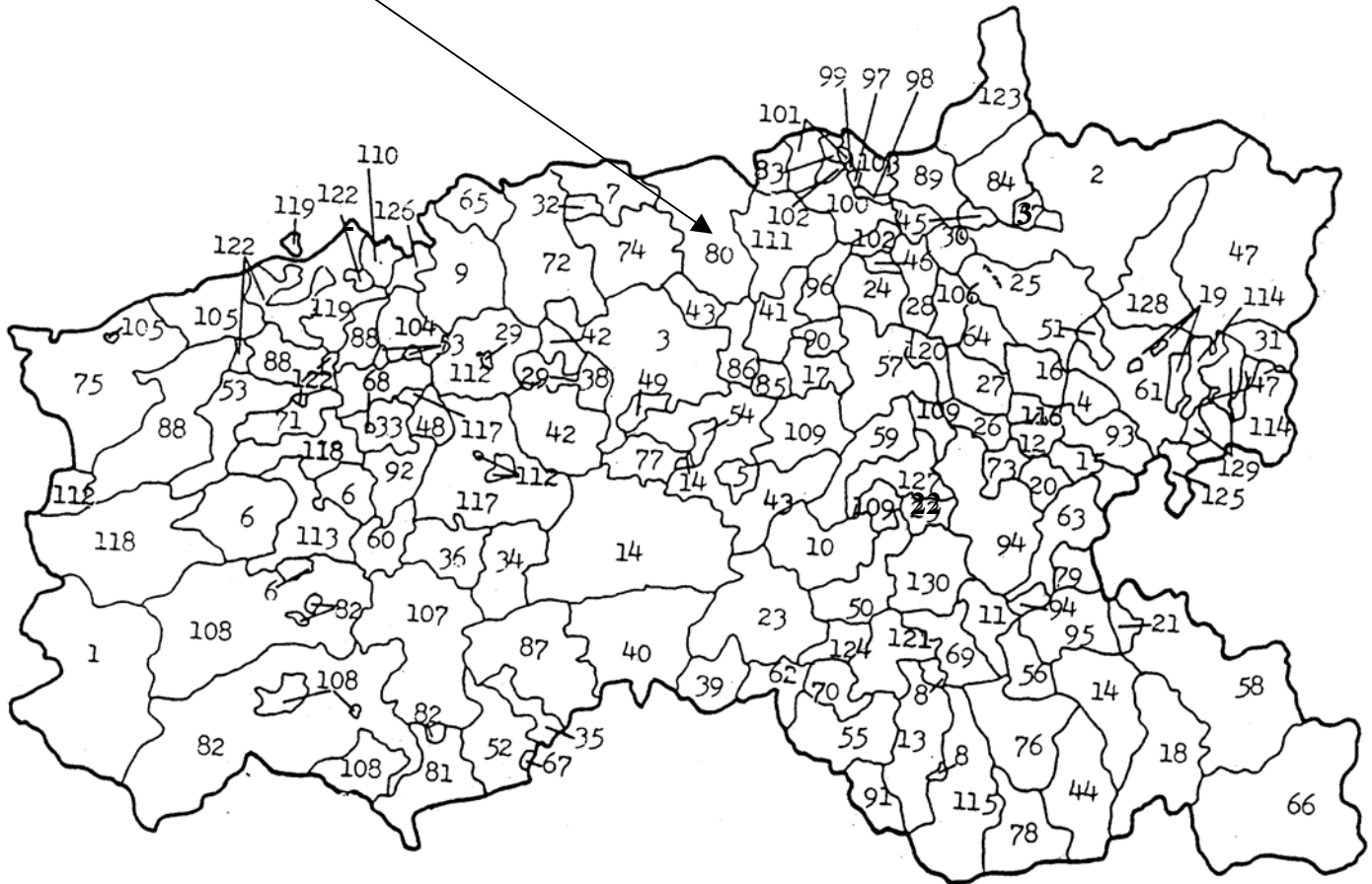

This parish is situated in the N. of the county, and contains 8,881 acres, statute measure. It is bounded on the N. by the River Shannon; S. by the phs. of Croom & Mungret; E. by Mungret Ph.; and W. by Kildimo Ph.

According to Ferrar in his History of Limerick, the parish is a Rectory and Vicarage in the Diocese of Limerick, in the gift of the Queen or Bishop. It is of a rectangular shape. Its greatest length, from Newtown in the N. to Ballyanrahan W., is $5\frac{1}{2}$ statute miles; and its greatest breadth, from Corcamore Td. in the W. to Tervoe Td. in the E., is $3\frac{1}{2}$ statute miles. The surface is a beautiful and richly productive tract of country, along the right bank of the River Maigue to the estuary of the Shannon.

St. Patrick's Well, with the image of the saint on a stone, is in this td, but no stations are performed at it. In this td. is, also, part of Patrick's Well Village, containing 41 houses: 3 taylors, 2 shoemakers, 1 brogue maker, 4 lodging houses, 1 weaver, 1 summons server, and a Petty Sessions clerk.

The Courtyard was of very irregular form, and its walls still stand except for 3 breaches. Its greatest length from N. to S. was about 3½ chains, and its greatest width from E. to W. about 3 chains. According to Fitzgerald and Mc Gregor, Brien Duff, son of Connor O'Brien, King of Thomond, settled here in 1406. It was taken and blown up by order of General Ginkle in September 1691.

Saint Patrick's well Village

Situated on the boundary between the parishes of Kilkeedy and Killonahan, in the Tds. of Ballyanrahan and Attyflin.

This village contains 41 houses, 3 publicans, 2 blacksmiths, 2 carpenters, 4 masons, 1 broguemaker, 3 hucksters, 3 taylors, 2 shoemakers, 4 lodging houses, a Police Station containing 1 constable and 7 subconstables, a Court House, and a Post Office established in 1828. There are 6 fairs held here on the following dates: 26th Februray, 28th April, 16th June, 14th August, 20th October, and 17th December. The village is the joint property of John Westropp, Esq., Attyflin, and A. O'Grady Rose, Esq., Limerick.

River Maigue -- B.S.S.M. 44

Abha na Máighe, river of the plain.
