

This parish is bounded on the N. by Monagay Ph.; W. by part of the County of Kerry and by Abbeyfeale Ph.; S. by Cork County; and E. by the Phs. of Killagholehane, Drumcullaher and Mahoonagh. It is situated in the extreme S.W. end of the county, and contains 25,456 statute acres.

A great portion of the parish is mountainous and bog, the eastern side being the only part where cultivation has taken place to any extent. The road from Newcastle to Newmarket in the County of Cork passes through the East side. A large portion of the south-west side of the parish is bounded by the River Feale. Three townlands are separated from the rest of the parish by a narrow portion of the Parish of Monagay.
