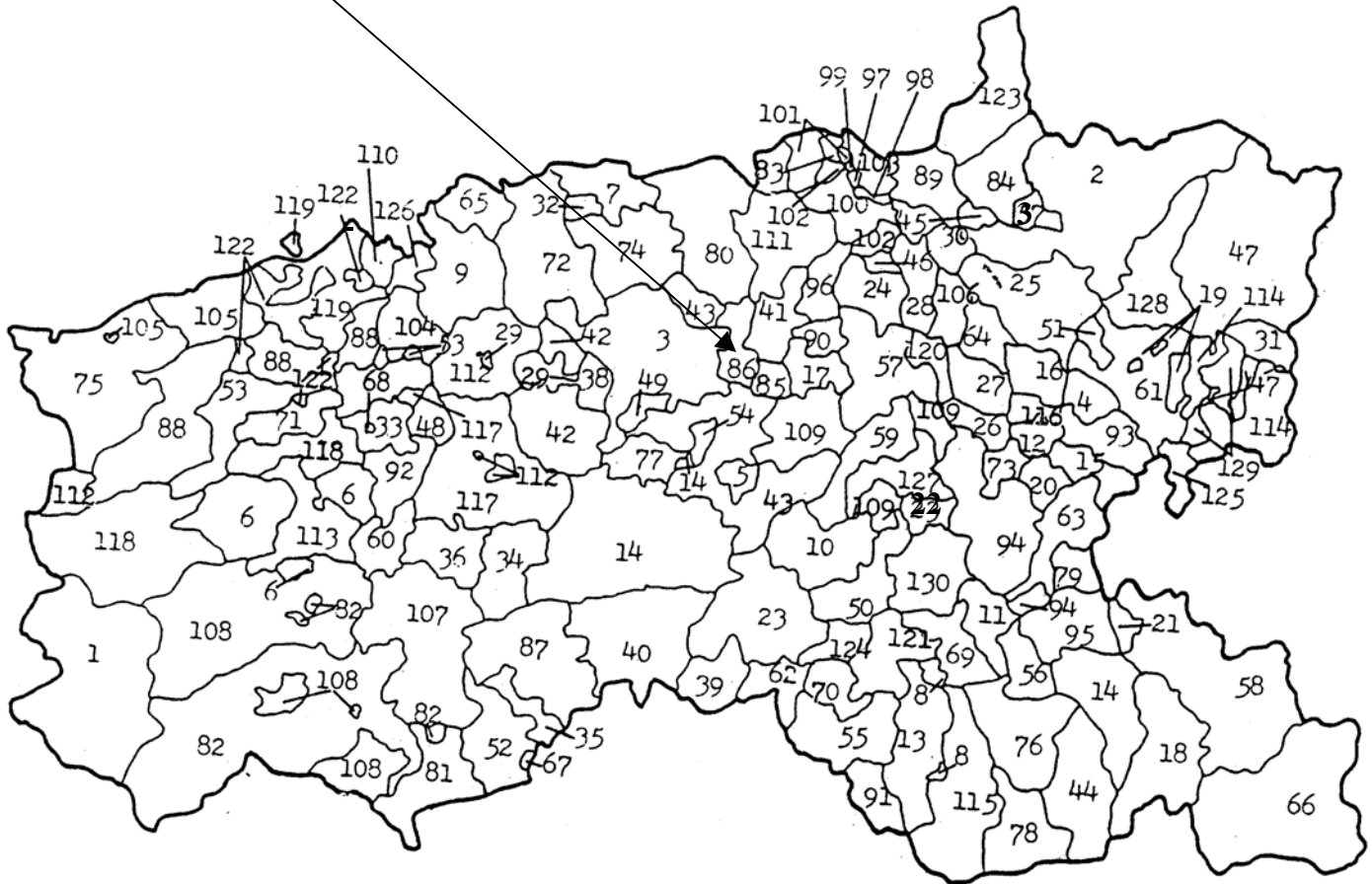

Situated in the N. of the Co. of Limerick. It is bounded on the N. by Kilkeedy Ph.; S. by Croom Ph.; E. by Killeenoghty and Crceora Phs.; and W. by the Parish of Adare. It contains 2,068 statute acres, of which 1,196 are in the barony of Pubblebrien and 872 in the barony of Coshma.

It is nearly in the form of a sandglass, getting very narrow in the centre, where it is only 3 furlongs from E. to W. Its greatest length from the junction of four cross roads in the N. at the td. of Attyflin to the td. of Garraunroe - measuring along the road from Croom to Patrickswell - is 3 statute miles; and its greatest breadth from Garraunroe Td. in the W. to Killanahan Td. in the E. is 1 m. 3 fur.

Situated in the N. portion of the parish, in the barony of Pubblebrien. It contains 440 st. acres.

It is the property of John Westropp, Esq., Attyflin. Let to 5 occupying tenants on a lease at 23s. per acre. Co. Cess per acre yearly 3s. to 3s.4d. Tithe per acre 3s. to 3s.6d. Size of farms 1 to 7 acres. There are 24 labourers who hold small portions at £1 14s. 1½d. per acre. Soil argillaceous, producing wheat, oats, barley

and potatoes. Prevailing Names: Cavanagh and Costello. Attyflin House, the residence of the proprietor, is a commodious house, newly roofed in 1817. It has a good set of offices, a garden, a well-planted demesne, and a splendid Gate House of cut stone. On the gate is a female figure, feeding an eagle.

It is the property of Thomas Brazill, Esq., Limerick. Middleman, Edward Taylor Massy, on a lease of lives, who sublets to 4 tenants, one on a lease of lives, the rest at will; rent per acre from £3 to £4. Co. Cess per acre yearly 2s. to 2s.8d. Tithe per acre 20d. to 2s.6d. Size of farms 8 to 44 acres. Soil argillaceous, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names: Potter. Spring Lodge, the residence of Mr. Potter, is a neat house, repaired in 1827. There are a garden and an orchard attached to it, together with ornamental ground and planting.

Riggs, Esq., Bruff, who sublets to Michael Brudie (?), Esq., M.D., Limerick, on a lease of 3 lives at £1 5s. per acre, who in his turn sublets to 9 tenants on leases of 2 lives at a rent of from £1 10s. to £2 2s. per acre. Co. Cess per acre yearly from 3s.2d. to 3s.10d. Tithe per acre 2s.3d. Size of farms from 2 to 29 acres. Soil loamy, producing wheat, oats & potatoes. Fuel scarce. Prevailing Names: Hartigan and Dundon.

There is a school here, containing 30 boys and 20 girls, all Roman Catholics.

The property of Henry Hartropp, Esq., London. Agent, Sir David Roche. Middleman, Thomas Grady, who rents at 16s. per acre for his own life, and who sublets to 4 tenants at from 23s. to 40s. per acre. Co. Cess per acre yearly 3s. to 3s.3d. Tithe per acre 20d. to 2s. Size of farms -  $1\frac{1}{2}$  to 27 acres. Soil argillaceous, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names: Irvin and Molony. The ruins of Ballylusky house stand here, formerly the residence of the Dawson family. There are 3 ancient forts in this td.

Waller O'Grady, Esq., is 3 stories high and in good repair; there are a good garden and a few trees. The house was built in 1790 by Thos. Peacock, decd.
