Situated on the Mulkear River, in the east end of the parish and on the parish boundary between Kilmurry and Stradbally or Castleconnell. It is on the road leading from Limerick to Castleconnell.

According to the local belief, this bridge has taken its name from a woman named Anne, who kept a cot on the river previous to the building of the bridge. The bridge is about 2 chains long, 20 feet broad, and has 5 arches which are 8 feet high. It was built at the expense of the county.

Roselawn _____ J. O'D. Situated in the north end of the townland of Castletroy and about 10 chains from the River Shannon.

This house is said to have been built in 1806 by a gentleman named Chaytor. It is now the seat of Mr. McKern, a non-resident. It is 40 ft. long, 30 broad, and 2 story high. It is seated within view of the Shannon.

Willow Bank House -- Local Willow Bank -- J. O'D.

Situated in the west side of Castletroy Td. and within 2 chains of Newcastle Td.

This house was built by Captain Hickey in 1825 at the expense of £550. It is 2 story high, 36 ft. long and 33 ft. broad. It is seated on an eminence overlooking the River Shannon.

Kilmurry Glebe House -- Local

See name of parish. J. O'D.

Situated in the west end of the Glebe of Kilmurry, and within 2 chains of the east side of the road from Willow Bank House to the Church of Kilmurry.

This house was built by the Revd. Maunsell, Parish Minister, in 1838, at the expense of £550 to be charged to his successor in that parish. It is handsomely built, is 2 story high, about 60 ft. long, and about 30 ft. broad.

Situated in the west end of the Glebe of Kilmurry, and within 1 chain of the boundary between Newcastle Td. and the Glebe.

This church was rebuilt in 1824 by the Board of First Fruits. It is 2 story high, 50 ft. long and 25 ft. broad.

Plassy Mill

Situated in the west end of the td. of Sreelane or Milford, and about 1 chain south of the River Shannon.

This mill was built by Major Maunsell in 1819 at the expense of £21,000. It is 7 story high and about 60 ft. long and 45 ft. broad. It is now in the possession of Harvey and Brother.

Situated in the centre of the td. of Sreelane or Milford, and about 7 chains south of the River Shannon.

This house was built by Major Maunsell in 1819, and is now in the possession of James Harvey, Esq. It is 3 story high, 72 ft. long and 40 ft. broad. It is seated on an eminence overlooking the Shannon on the East and the City of Limerick on the N.

Situated in the west end of the parish and in Ballysimon Td. It is on the River Groody.

This bridge was built in or about 1800 at the expense of the County. It is 32 ft. long, 15 ft. broad, and with 2 small arches about 4 ft. high.

This mill is 4 story high, 80 ft. long and 60 ft. wide. It is now in the possession of Samuel Dickson, proprietor of Ballysimon Td.
