STEWARDS' FARM ACCOUNTS, Published by M. Glashan, Dublin.

We (LIMERICE CHRONICLE) have frequently adverted to the writings of Mr. Kingsley, which have proved that he is conversant with the principles of accounts, especially of those parts wherein persons are liable to commit errors.

Three Formularies have heen recently published by that gentleman, namely, a Registry of Work Book, to record the names of labourers and the wages earned and paid, &c.; an Abstract Report thereof, and the Form of a Return shewing the receipts and disbursements of the steward. We shall notice the two latter only, as some original matter is put forward by that gentleman which renders them valuable to the country gentlemen. These Forms are printed on a sheet of letter paper, which, when filled up by the steward, is to be laid before his employer at the end of the week, or, in his absence, that agent might forward them by post to his address. The cost will not exceed one penny. On one page, the labour of the week (shewing the number of days the labourers were employed, the wages earned, and the cash paid,) is to be copied from the Registry of work book already alluded to. On the other page is a cash account, shewing the receipts and disbursements of the steward for that particular week for which the return of labour is set forward. This department of farming is before the employer every week in the year, with a precision hitherto unattainable. In our experienced judgment, the most valuable feature in these returns is, that the balance of cash remaining in the custody of the steward is regularly carried forward by him from week to week. That is as it should be ; and Mr. Kingsley recommends that the report of the steward should be a literal copy of his cash-book, instead of an abstract thereof. The form, as constructed by that gentleman, is admirably adapted as a model of that record. On a superficial examination, these forms will be found far superior in utility and in simplicity of design, to any agricultural forms of that character coming under our observation.

The only Galway landlords who have applied for loans under the recent statute, are John Lambert, Esq. for a sum of £1,200, for improvements on the lands of Ballinahinch, and John Augustus O'Neill, Esq., for £6,400, or thereabouts, for drainage of his estate of a similar denomination.
