Cnocknegaule -- Civil Survey 1654-56

This parish is situated in the north of the County Limerick and Barony of Pubblebrien and County of the City of Limerick. It is bounded on the N. by the phs. of Mungret and St. Nicholas; S. by Kilpeacon Ph.; E. by the phs. of Caheravally and Fedamore; and W. by Crecora Ph. It contains 2172 acres, statute measure.

It is a Vicarage in the Diocese of Limerick, according to Ferrar; but, according to Fitzgerald, it is a Rectory. It is oblong in form. Its greatest length from Ballyclogh in the N. to Greenhills in the S. is 3 statute miles, and its greatest width, from Derryknockane in the W. to the east of the td. of Ballyclogh, is 1 mile 3 furlongs.

Situated in the north extremity of the parish. It is bounded on the East by a road connecting Limerick and Croom. There is one fort in this td. It contains 361 acres.

It is the property of Michael Furnell, Esq., Caherelly, who lets 60 acres to Edmund Morony at £2 2s. per acre, on a lease for ever, and 42 acres to Mr. Russell, Limerick, at £2 2s. per acre on a lease of 1 life. There are 18 other occupying tenants who pay from 50s. to 65s. per acre. Co. Cess per acre yearly 9s. to 12s. Tithe per acre 2s. to 2s.6d. Size of farms - 4 to 17 acres. Soil argillaceous, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names: Rahally and Collopy. There is a Flour Mill

Situated in the north of the parish of Mungret, in the County of the City of Limerick. Contains 350 acres.

The property of George Gloster, Esq., Limerick. Let to 8 tenants, one having a lease of his own life, the rest at will. Rent per acre 34s. to 45s. Co. Cess per acre yearly 9s. to 10s. Tithe per acre 2s. to 2s.6d. Size of farms, 4 to 21 acres. Soil part argillaceous and part light reclaimed bog, producing wheat, oats and potatoes. Fuel scarce. Frevailing Names: Lyons and Sexton. A principal part of this td. is occupied by the proprietor, and is undergoing considerable improvement. There is an old dilapidated house here, with an orchard and a new range of offices.

There is a good set of offices annexed. There are the ruins of an old church and burial ground 10 chains S. of the Glebe House.

The property of Edward Villiers, Esq. Agent George Briscoe, Co. Kilkenny. Middleman, John Tuthill, Esq. at £1 per acre, on a lease of lives renewable for ever, who sublets to 12 tenants, some on leases, some at will; rent 34s. to 50s. per acre. Co. Cess per acre yearly 3s.6d. Tithe paid by the landlord. Size of farms, 10 to 70 acres.

Human bones have been found when digging in the vicinity of this place.
