the admiration of all Europe; it may be viewed in the light of a national militia, constituted in such a manner as to increase rather than diminish population; of this force one half are the sons of peasants, labourers, and other persons employed in agriculture, who during the months of April and May are exercised in military evolutions, and who afterwards return to their families and rural occupations. The other half of the army, which consists of foreign mercenaries, naturalized in to Prussians by the power of discipline, commonly reside with their regiments in the different towns, where they attend military duty two days in the week, and employ the rest of their time in different kinds of labour, which a general spring of activity universally offers to the hand of industry in all parts of the Prussian territories.

In towns and garrisons marriages is not discouraged among the soldiers. Every regiment has a number of women and children belonging to it not less than of men. The Prussian army which consists of 100,000 soldiers, when their wives and children are added, amounts to 400,000 souls. A house is also established at Potsdam for the maintenance of five hundred children of soldiers; a great part of whom, after they have attained the age of eight years, are sent into the country to be brought up among the peasants, who are allowed for the subsistence of each thirteen crowns a year.

## DUBLIN, October 27.

It is much to be apprehended that the Algerines will be totally dissatisfied that one of their vessels was suffered to be destroyed when under the immediate protection of the guns of Gibraltar. Very probably the Dey may give orders to make a retaliation, but he must be soon sensible of his mistake, as his cruizers have no other port to take shelter in, if pursued up the Straights, where they can possibly find refuge but that already mentioned. Independent of this circumstance, the British fleet, which is constantly stationed in the Mediterranean, would be ordered to make reprisals, and the merchant vessels for the Levant, Archipelago, and Italian trades, would necessarily sail under sufficient convoy. Thus these depredators could make very little by the dispute, while their naval force might be almost en-
