This is a northern parish of Shanid Barony, containing 5,153 acres, including a detached portion of 216 acres. It is bounded on the N. by the R. Shannon; E. by the phs. of Shanagolden and Robertstown; S. by Kilmoylan Ph. and part of Shanagolden Ph.; and W. by Kilfergus Ph.

The parish contains 30 Protestants, and, according to the Revd. Daniel O'Sullivan, P.P. there are 2,000 Roman Catholics between this parish and Kilfergus Ph., but he gives no information for either parish separately. The crops generally sown are potatoes, oats, flax, and a little wheat. The corn is generally brought to Rathkeale for sale, and thence to Limerick for export. The soil in general is coarse and spungy. Lime is entirely used for manure, the limestone being brought from Askeaton. Wages of farm servants:-Males, £4, Females, £2 per annum, with board; Labourers, 8d. per day in summer, 6d. per day in winter.

There is a school in Mount Trenchard, established in 1839, and attended by 76 scholars, consisting of 45 males and 31 females. Only one of the scholars is a Protestant. The school is supported by the parents.
