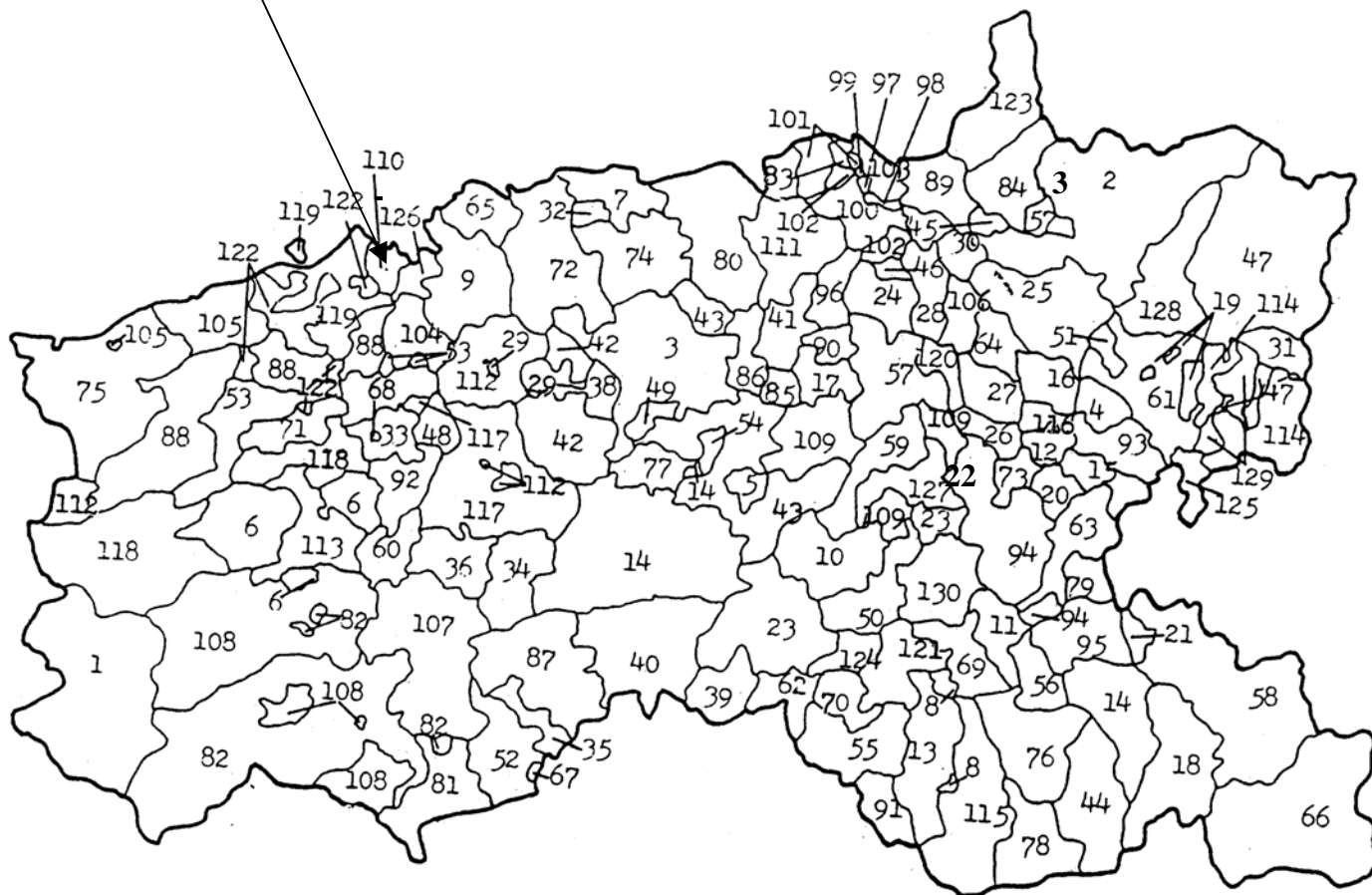

This parish is of a rectangular form. Its greatest length from N. to S. is $1\frac{3}{4}$ statute miles, and its greatest width from E. to W. is 1 mile 5 furlongs.

Situated in the south of the parish, and contains 405 acres. It is bounded on the N. by a road, and traversed from E. to W. by a second road.

The property of the Earl of Cork. Agent, Daniel Leahy, Esq. Middlemen, Lancelott Sandes, Esq., who sublets to 20 tenants on a lease of years at from 25s. to 32s. per acre. Co. Cess per acre 2s.6d. to 3s. Tithe, 1s. per acre. Size of farms, 5 to 50 acres. Soil argillaceous, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names - Maddigan. There is a school here, containing 90 boys and 50 girls, all Roman Catholics. The teacher is paid by the pupils.
