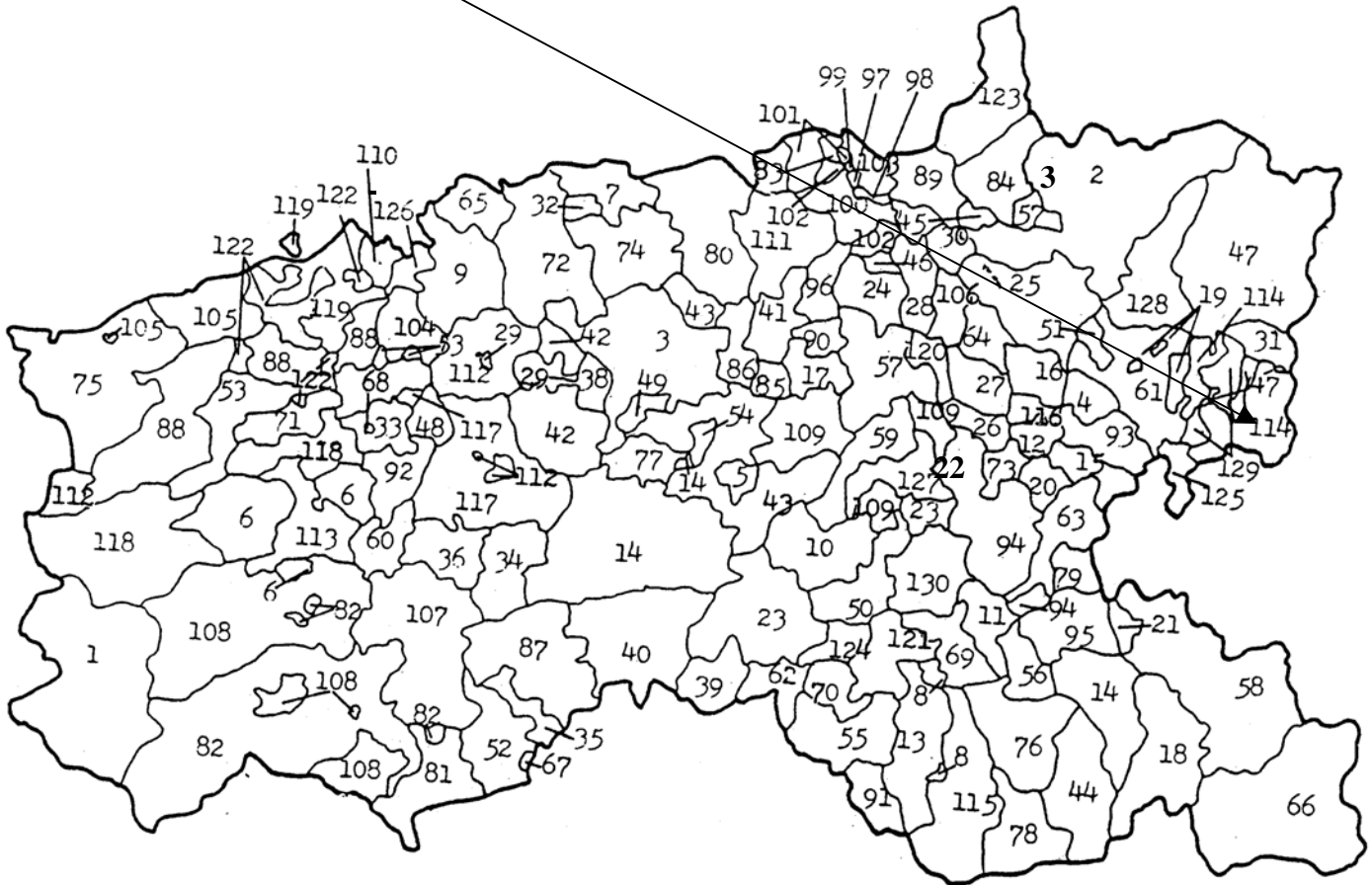

Situated about 12 miles S.E. of the City of Limerick. It is bounded on the E. and S. by the County of Tipperary; N. by the parish of Doon; and W. by the phs. of Tuoghcluggin and Templebredon.

This parish is about 4 miles long and nearly 3 miles broad. It is well convenienced with an excellent line of road leading from Limerick to Tipperary through its centre, besides another crossing this nearly at right angles in the centre and leading from Cappamore to Pallas Green &c. It contains 43 townlands, 36 of which are very level, and the remainder, including Oola Hills, provide excellent pasture lands. It is all arable, and fuel is consequently the scarcest accomodation.

It is curiously formed by nature in a solid rock, having always a depth of 6 inches of water in it, and it is said that neither the greatest drought nor the heaviest rainfall decreases or fills it. Its formation, as told by the natives, is as follows:

The family of Oola Castle lacked water and appealed to the Pope, who consecrated a bottle of water for them. The property of this water was that, when poured on the spot where is now the well, a well of excellent water appeared, rendering enough at all times, though not supplied from any other source. The people also affirm that the water of this well cannot be made to boil by any heat.
