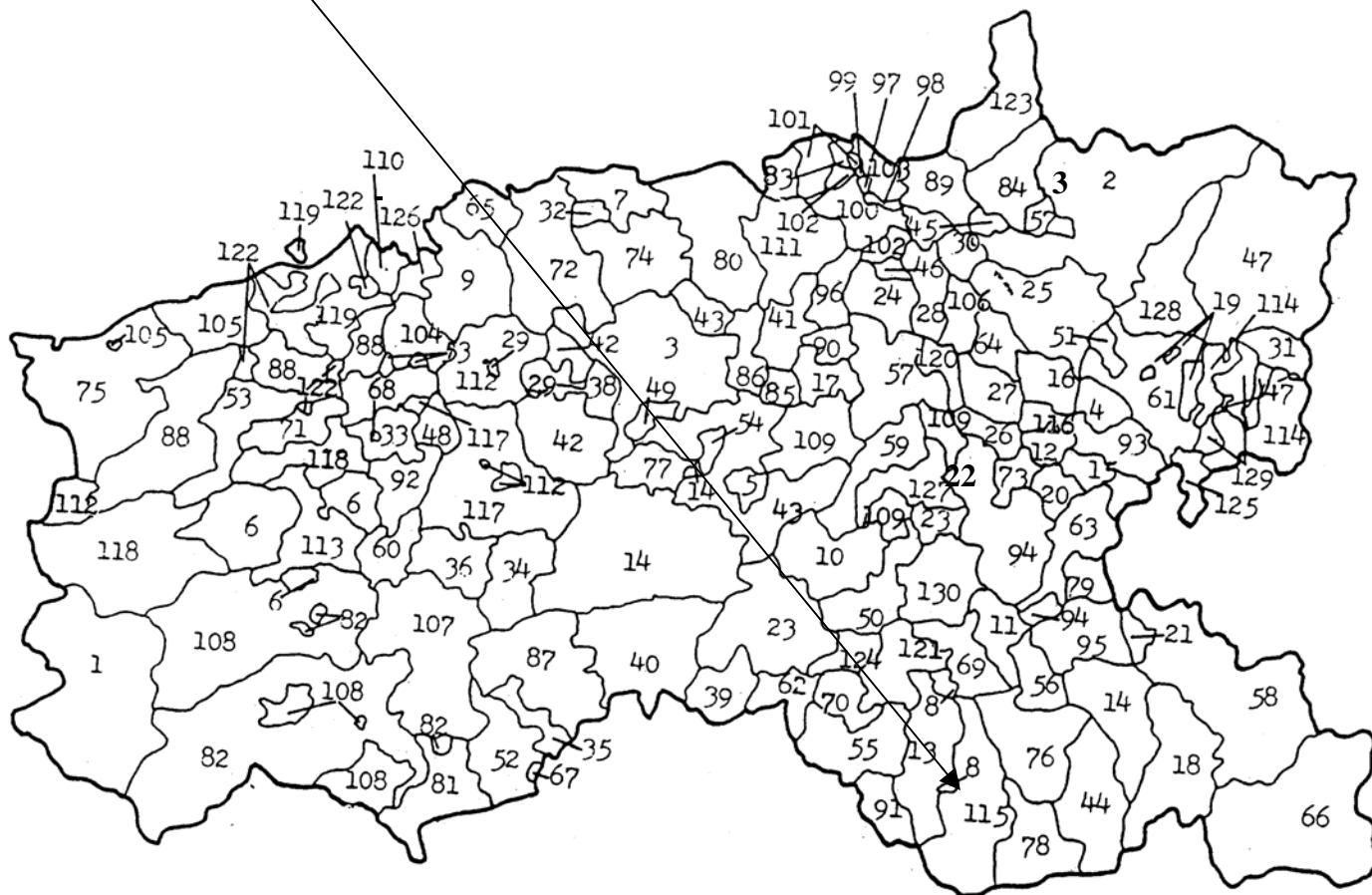

Is the property of Richard Oliver Gascoigne, Esq., and contains 349a. 3r. 25p. statute measure. There are a few small portions of rough pasturage interspersed; the remainder is arable. There are 2 roads bearing nearly E. and W. across the td.; one is about the centre, the other in the N., of the td. Between these two roads stands Ballybeg House. In the S. of the td. is an ancient

fort, called Ballygeagoge fort. In the E. of the td., near the road about the centre, stand the ruins of an old-mill.

Is the property of Lord Portarlinton, Yorkshire, & contains 786a. 3r. 30p. statute measure. There is much ornamental ground in this td., in the centre of which stands Castle Oliver. In the north part of the planted portion are two ponds. The road leading to Kildorrery forms the southern boundary.

Is the property of Silver Oliver, Esq., Vienna, and contains 604a. 3r. 35p. statute measure. Nearly half, towards the south, is mountain. There is a good road which crosses the td. towards the N., which leads to Kildorrery. A stream on the W. divides it from Toor, and another on the E., running N. through the Mountain, divides it from Glenosheen. There are several houses in the td., and on the top of a high mountain is a rock, called Black Rock.

Is the property of Silver Oliver, Esq., Vienna, and contains 773a. 2r. 5p. statute measure. About $\frac{1}{2}$ arable; remainder mainly mountain, with a portion of wood on the West. There are several roads and houses interspersed. Long Mountain on the S. and Seefin on the W. are the principal heights.

Is the property of Richard Oliver Gascoigne, Esq., and contains 1151a. 3r. 4p. statute measure. S. of the td. there is a small portion of arable land; the remainder is mountain of a boggy nature. Adjacent to the S. boundary is a plantation of trees. About the centre of the td. is a Trigl. Station, Glenanair W., 1140 feet above the sea.

In the south of the parish. Bounded on the N. by Fanningstown; W. by Glenanair West; E. by Glenasheen; and S. by Ballintlea East (Doneraile ph.).

Is the property of Richard Oliver Gascoigne, Esq., and contains 1322a. 0r. 8p. statute measure. About one-fifth of the td., towards the South, is arable land; the remainder is a mountain of a boggy nature. In the S. there is a road bearing N.W. and S.E. through the arable portion. The east boundary is the centre of a road. In the N. of the td. is the Trigl. Point of Glenanair R., 1738 feet above the level of the sea.

Is the property of Peter Lowe, Esq. It contains 340a. 2r. 10p. statute measure. All arable land. The centre of the road from Kilmallock to Killfinane, forms part of the south boundary, near which, and adjacent to the west boundary, is a neat house with a small orchard attached. There are several houses interspersed throughout the td.

The road from Charleville to Kilfinnane passes E. and W. about the centre of the td. South of this road there is a neat house with offices, Called Bullafin Cottage. The fences through the td. are all planted with trees. There are two forts, one in the South; the other, a remarkably large one, is in the East and is called Mortlestown Fort after the td.

Is the property of Edwd. Sayers, Esq., Sunville. It contains 287a. 2r. 37p. statute measure. About one-fifth of the td., in the North, is a meadow pasture. In the S. of the td. there is a Gentleman's Seat, a neat house with suitable offices, garden, etc. The front or south side of the house is beautifully ornamented with wood and water. The house is called Sunville House. To the west of it there is an excellent corn mill.

Is the property of Richd. Oliver Gascoigne, Esq., and contains 554a. Or. 6p. statute measure. All arable and pasture except a small portion of bog on the east side. There are 2 forts here, one near the N., and the other more west, near Knockbrack Hill, and called Knockbrack Fort. In the N.W. corner, near the cross-roads, stands a R. C. Chapel, and to the east of the chapel is St. Anne's well.

Is the property of Silver Oliver, Esq. Contains 492a. 2r. 24p. statute measure. It is the most western townland and contains a great tract of mountain towards the South and Greg Mountain on the West; the remainder is arable. The parish boundary is a lockspitted line along the mountain from Greg (Graig) Mountain to Castle Philip Rock. There are some old roads and a few houses in this td.

There is an excellent modern house with offices standing in the middle of the td., to the east of which is the mock castle, from which the townland and house derive their name.
