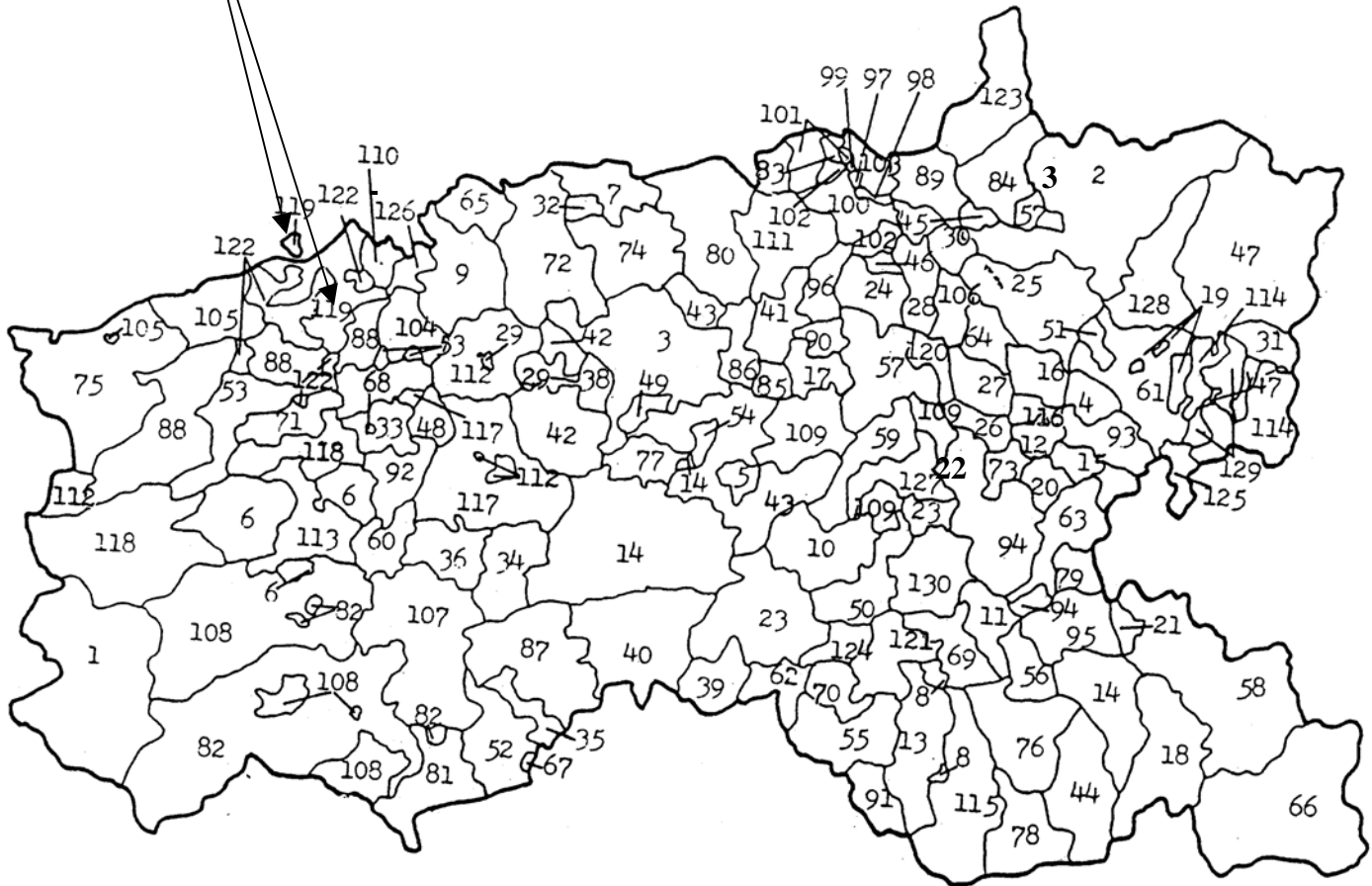

This parish is situated in the Barony of Shanid, on the R. Shannon, 4 miles W. from Askeaton, on the road from Limerick to Tarbert.

It is a very irregular shape and is divided into two portions, namely, N.W. and S.E. The extent of the N.W. portion from the td. of Durnish to Knockpatrick in the S. is $2\frac{1}{4}$ statute miles, and from E. to W. is $1\frac{1}{2}$ st. miles. According to Fitzgerald, in his History of Limerick, it is a Rectory and Vicarage united with Dunmoylan in the Diocese of Limerick.
