

Tuesday week is appointed for the election of a Life Commissioner of St. Michael's parish, in place of the late John Tuthill, Esq.

This worthy Clergyman's remains were attended to the grave, by a number of Ministers of the Established Church, and by several Clergymen of the Roman Catholic persuasion, together with a large body of his friends and relatives, and a vast concourse of his tenantry, (wearing scarfs and hat-bands,) by whom he was deservedly esteemed for his worth as a landlord. Upwards of 40 carriages followed in the mournful procession which left Fairy-field on Wednesday, and passed through Kilmallock, direct to Kilmannin, where the body of the deceased was interred in the family vault.

On Tuesday the remains of Mrs. Warburton, which left this city on Monday, were deposited in Bishop Warburton's tomb in the Cathedral of Cloyne. The crowds who attended the funeral on its procession from Midleton, testified the respect and regard in which the family of that respected Prelate was held, and is evidence of the policy which has deprived Cloyne and its neighbourhood of the blessings of a resident Bishop. Hundreds of the lower orders flocked to witness the last sad rites of mortality, and the lamentations of many a poor creature who had often been relieved by the departed, seemed to mourn by gone times, as if their benefactors were lost for ever. Besides the immediate relatives, Archdeacons Warburton and Maunsell, Colonel and the Messrs. Warburton, there were present F. Rowland, Esq.; Rev. R. Deane Freeman; John Lawless, Esq.; Doctor Butt; James Hanning, Esq.; Rev. Messrs. Jones, Fairtlough, Mongan, Doctor Hingston, Rogers, Welland, Daly, Wilkinson, Adams, &c. There was a long train of carriages in attendance.
