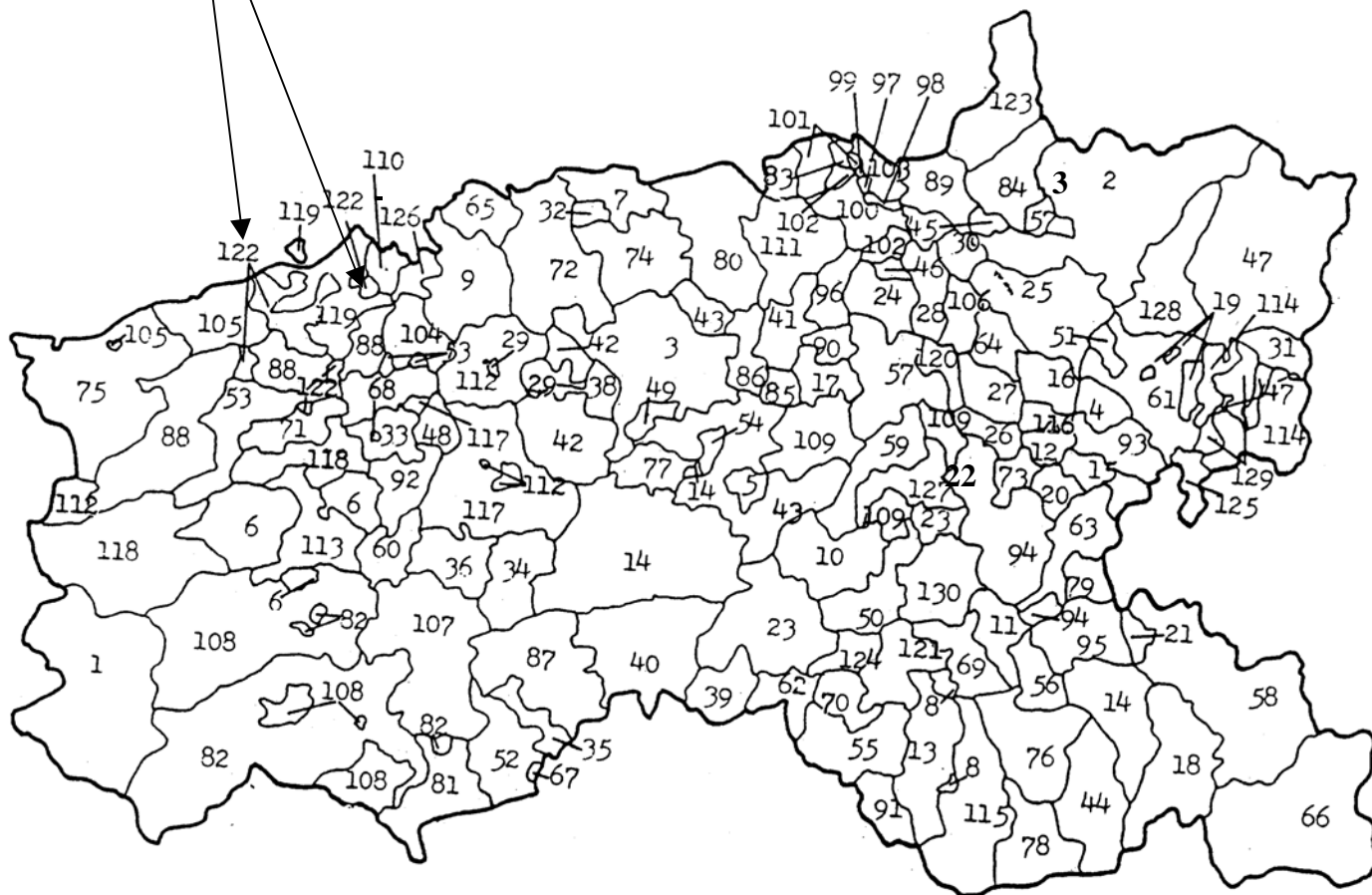

It is divided into several detached portions so that its length and breadth cannot be ascertained. About two-thirds of the land is under cultivation; the remainder is rough pasturage. According to Ferrar, this parish is a Vicarage in the Diocese of Limerick; but Fitzgerald calls it a Rectory.
