LANDED ESTATES COURT-July 15. (Before Judge Longfield.)

In the Matter of the Estate of John William Burmester. Mr. May applied in this case for payment to Thomas Joseph Eyre of a sum of £17,655 12s. 6d., in part discharge of the amount due to him on foot of advances which he made to the Earl of Kingston and Henry Smith, under a deed dated 1854, in part discharge of a sum of £18,000, being the amount of instalments of £3,000 per annum, due to him under the 11d., payable to him under an order of the court dated June, 1862. It appeared from the affidavits that in the year 1845 Mr. Eyre had advanced to the Earl of Kingston a sum of £40,000, and that subsequently, on investigation of the account between them, there remained due on foot of interest a sum of upwards of £7,000. Subsequent to the death of Mr. John Sadlier Mr. Eyre had been in the receipt of the rents of the Kingston estates for payment of his demand, and he had policies of insurance and other securities. Some years since the Earl of Kingston instituted a suit against Mr. Eyre and Mr. James Sadlier, representa tive of the Tipperary Bank, in relation to those advances, and for an account of the rents of the estate, and it then appeared that there was a sum of £18,000 due to the Earl by Mr. John Sadleir, who had been previously appointed receiver over the estate under a private arrangement. As to these claims a release was alleged to have been executed in 1855, and this matter formed the subject of proceedings before Judge Longfield, in October, 1859. It was then decided that this release was void as against any surplus coming to John Sadleir, but that it was valid as regarded the claim of the London and County Bank. This decision was confirmed by the Court of Chancery Appeal, and the matter was brought before the House of Lords, when the Irish decision was over turned. Mr. Eyre's present claim was for the portion of the sum which, under these circumstances, he was

Mr. Foley opposed the payment. The Court decided that Mr. Eyre was entitled to the advances, amounting to £1,005.

CITY SESSIONS-TUESDAY, JULY 15.

The Right Hon. the Recorder sat to-day, in the Court-house, Green-street, for the trial of prisoners. John Crawford was indicted for obtaining, under false and fraudulent pretences, a quantity of thread, value about £10, from Messrs. Hayes and Company, Banbridge.

The prisoner, who represented himself as being a general merchant and commission agent, ordered the thread in his own name, to be sent to his residence, Cross-Kevin-street.

Mr. Henry Longden, Secretary to Stubbs' Trade Protection Society, proved the handwriting of the prisoner, and that he was not a general merchant or commission agent. He lived in a small room in Cross-Kevin-street, where there was hardly any furniture

The Recorder said that the jury could hardly find the prisoner guilty on the indictment, as there was no case against him. The prisoner ordered the goods in his own name, to be forwarded to his lodgings.

The jury found a verdict of "Not guilty."

He was bound in his own recognisance to take his trial on a second indictment, charging him with a simi-

lar offence. The Court then adjourned.

At Castlerea, a melancholy occurrence has taken place. A woman upwards of seventy years of age, the wife of a man named William Jervis, a pensioner, threw herself into the Upper Suck, at Cashel, near the Cloonalis, the residence of The O'Connor Don, M.P., and was drowned before assistance could be

The matter being reported, the police were promptly in attendance, and on entering the house, horrible to relate, they found William Jervis, the husband, who was known to be unwell some time previous, dead, and in such an advanced state of decomposition, that when the medical gentleman removed the clothing, a portion of the flesh was adhering to it, torn from the ribs, and even some of the ribs were displaced, while the stench was intolerable and overpowering, rendering it impossible for any one to remain near the body, which appeared to have been life less for six weeks, or more. It appears the wretched wife, who was afflicted with some mental disease for over thirty years, wished to conceal her husband's death in order to secure his pension when due; but dreading a discovery of his decease, which was beginning to be suspected, she destroyed herself.

A letter from Banbridge, dated July 15, says Scarva was the scene of great excitement during the entire of yesterday, as the usual annual sham fight came off, at which a number of strangers from Armagh attended, carrying banners, firearms, and music. They marched up and down the roads several times during the day. Another party of Orangemen, who intended joining the above, were intercepted at a place called Drumilla, by the Roman Catholic party, who would not let them pass, and succeeded in driving them back. No injuries were received by either party.

EXECUTION OF THOMAS BECKHAM. The last sentence of the law in the case of Thomas Beckham, convicted at the Special Commission for this

County, of the murder of Francis Fitzgerald, Esq., of Kilmallock, on the 16th of May last, and with the full particulars connected therewith our readers and the community at large are familiar, was carried into effect yesterday, by the execution of the criminal, on the gallows in front of the county gaol. There was an immense concourse of persons assembled before the prison about a quarter to twelve o'clock, the numbers swelling to between four or five thousand, including many females of the lower classes, whose anxiety to many temales of the lower classes, whose anxiety to gratify a morbid curiosity in such cases is generally and unhappily very great. The Constabulary, consisting of a party of 120 men, under Sub Inspectors Hamilton, Channer, Fulton, and Madders, took up positions outside and inside the prison at a quarter past algary the Under Sheriff George I Hove past eleven, the Under Sheriff, George J. Hore, Fan having previously arrived at the good to discharge the painful duty of having the latal sentence of the law carried out, and which duty he saw fulfilled with every consideration to the position of the unfortunate man. The admissions to the gaol were almost exclusively confined, and very paoperly, to the members of the Press, and the Roman Catholic Clergy who attended Beckham to the scaffold. Before the Priests arrived the Sisters of Mercy were with the culprit in the condemned cell, affording religious consolation, and as much has been said in connexion with the calcusness with which the felon met his ignominous fate, and ascribed by many to an aberation of intellect on his part, it-is not out of place to relate an incident which came under our observation. On these good ladies leaving bim, when the Priests entered the cell, Beckham rushed out in an excited manner into the yard as far as the iron paling permitted, and called hastily and aloud "Ladies! Ladies!! I want to speak to you." The two sisters returned to the gateway entrance, whereupon he smiled approvingly, and throwing himself upon his knees, gave them his blessing, returned thanks for their attentions, and said "All is right now." When he stood up he observed two little boys who were in attendance upon the Priests, pass out, and hastily said "come here boys, I want ye." One approached him, and putting his hand in his pocket, he gave him a threepenny bit, and as the other would not go near him, he threw a similar coin out on the flag-way to him, telling them to "take that in remembrance of me." The dergymen were observers of this and then called Beckham to re-enter the cell, towards which he quickly walked rubbing his hands and laughing, saying "all is right, all is right." He there remained with the clergy until five minutes past twelve, when summoned by the Sheriff and Governor to be brought out for execution, and the procession moved forward. Beckham maintaining a sort of reckless indifference, while at the same time he responded with apparent earnestness to the prayers recited, carrying a crucifix in his hand. The clergymen were Rev. Mr. Fitzgerald, P.P., St. John's, Rev. Thomas Fitzgerald, of Kilmallock, Rev. Mr. Shanahan, PP, St. Mary's, Rev. Messrs. Conway Sullivan, and Corbett. On reaching the top of the roof where the gallows stood, Beckham looked the rope, and for an instant seemed as if moved but momentarily gained his self possession again. He stood, and the Rev. Mr. Fitzgerald told him that was the place for him to speak if he had auything to say. Beckham replied "no, I will speak when I go up," and walking forward he actually ran up the drop stairs, to the astonishment of all present. On gazing around he was not amazed at the immense concourse he saw beneath him, and when joined by the officiating clergymen on the scaffold, he proceeded to address them a loud tone, laying emphasis on his observations by standing upon his toes and stamping with his heels. He -"I am Thomas Beckham of the County of Limerick; I am. Friends and neighbours of county of Limerick, I give my whole blessing to the beloved women and men of Limerick. I did not turn stag or turncoat against any man, but stand on my own way of living. I forgive every one from the bottom of my heart out. As to Mrs. Fitzgerald, of Kilmallock, I say that she did not bless her soul aright; still and all, I forgive her and all my enemies from the bottom of my heart. I am no spie or turncoat-No. (Here the son of the wretched man, who stood in the crowd, cried out, "Bravo, father, I knew you would die true," and the crowd responded by a cheer). I hope this day that Almighty God, through honour of the Blessed Virgiu, will forgive my soul. That is all I have to do. I want to let you know that I never was a turncoat or stag. I am the first man of my name from my part of the country that ever was hanged at the gallows. I never informed or went over. I ask you all to pray to God to have mercy on me." After a pause he said in a loud voice, and on saying it gave a bound ou the drop, "I am Tom Beckham, of the county Limerick." The culprit used some other expressions of a rambling nature, but was stopped by the Priest, who placed the crucifix before him, and desired him to pray for mercy, which he did.

The hangman being beckoned to approach, Beckham took off his cravat with his own hands, when the rope was adjusted around his neck, and the cap put on by the executioner who then withdrew, leaving him alone on the scaffold where he stood unmoved for about three minutes; the fatal bolt was drawn, and the wretched being was launched into eternity—he died

almost without a struggle.

Beckham, before being removed from his cell for execution returned thanks to Mr. Egar, the governor of the gaol; also to Doctor Gelston, physician of the gaol, and to his son, for their very kind treatment of him in seeing that he was supplied with everything he

required in the way of food and nourishment. It is said that the allusion made by Beckham to Mrs. Fitzgerald arose from, a statement he made in the prison the night before, that it was not his shot that killed Mr. Fitzgerald. If he did so, the reference to Mrs. Fitzgerald is supposed to express a point that was running in his mind-that she made a mistake in swearing he fired the first shot. the only point in which her evidence differed from the dying declaration of her husband, who stated it was the taller man of the two fired first, and this would accord

with the point said to have been made by Beckham. A circumstance that may serve to account for his callousness and seeming total want of moral sensibility is, that when a young man, however engaged in a fight at a fair, and a number of men fell upon him and beat him dreadfully about the head. He sustained severe injuries, one of the results of which was his loss of hear ing. His brain may have been injured, for, while in the prison, he put the fingers of some of the men in charge of him into deep furrows or holes in his head, caused by the blows he received.

Beckham, whose age was 61 years, was only married on Tuesday to the woman with whom he lived in a state of sin for 25 years.

It is expected the extreme sen tence will not be carried out, as the jury recommended the prisoner to mercy.

BANQUET TO M. ROUHER, THE FRENCH

MINIOIEN OF COMMENCE. A magnificent banquet was given to M. Rouher last night at Willis's Rooms. About 150 gentlemen were present, Mr. Milner Gibson presiding. In proposing the health of the Emperor of the French, he saidthat at no period had the relations between France and England been in a more satisfactory condition than at the present moment. The toast of the evening drew forth the remark that perhaps there was no instance in our history in which so large a number of members of parliament had invited to a banquet a minister of state from a foreign government. The chairman complimented M. Rouher on the courage, perseverance, ability, and good faith, displayed in effecting the commercial treaty, and stated that in the next trade returns it would be found that only two countries showed higher than France.

M. Rouher replied in French. He alluded to the acrimony, prejudices, and terrors the project of a party excited, and those political passions and excitements which, he said, imprudent minds can so easily excite between two powerful nations, each of which is justly proud of itself; but the initiative having been taken. France had broken through its old legislation on cereals and raw materials. France yester day signed treaties of commerce with Belgium and the Zolverin-to-morrow she will sign that which she is negociating with Italy. The banner of economical reform will thus continue its triumphant march, and will tend to extinguish political passions and ancient nimosities, and all these things are so many firm basis for a durable peace between the nations. M. Rouher concluded by proposing the close alliance of

Mr. Cooden spoke of the pacific designs of the Emperor.

THE VICEROY OF EGYPT.—His Highness the Viceroy of Egypt yesterday gave an entertainment, in Oriental style, on board his yacht, in order to testify his appreciation of the hospitality he has received during his visit to England. Covers were laid for 50 persons. The Duke and Duchess of Cambridge and some other members of the royal family were present, also five of the cabinet ministers, the Speaker of the House of Commons, the Lord Mayor, several foreign princes, the Duke and Duchess of Sutherland. The banquet went off admirably. Nothing could exceed its magnificence; some of the dishes of sevres china cost 100 guineas each. The Viceroy drank only water that of the Nile-during the banquet.

ARBIVAL OF THE PRINCE AND PRINCESS LOUIS AT DARMSTADT.—On Saturday afternoon their Royal Highness made their entry into Darmstadt. The streets and the houses were all decorated with the English and Hesse flags. Their Royal Highness proceeded in a carriage and six at a walking pace. All eyes were turned on the youthful princess, thousands greeted her with welcome, and flowers were showered on her in profusion. PARLIAMENTARY SUMMARY. HOUSE OF COMMONS-LAST EVENING.
