Ald Steve Coughlan TD, demanded from the Minister for Labour that he intervene immediately in the Cement dispute to bring about negotiations between the management and the unions.

Mr Michael Connelly, joint secretary of the Area Joint Council for the Building Industry in the Limerick Regional Area, today sent a telegram to the management of Cement Ltd at Mungret telling them that if they agreed to a conference with the picketing unions the unions would strongly recommend the withdrawal of pickets.

Cement Ltd replied saying they had passed the message on to the Federated Union of Employers.

Separately, talks were resuming in Dublin this afternoon in an effort to end the maintenance workers dispute. A further offer is expected to be made by the employers, which, it is hoped may bring the matter nearer solution.

THOMOND Park will be readily available to Limerick AFC for their big FAI Cup second round game with Waterford on Sunday March 2.

The North Munster Branch of the IRFU considered Limerick's application at their meeting last night. The Committee agreed to grant the application as there was no rugby match listed for the ground on that date.

Limerick AFC are almost definite

to switch the cup tie from the Markets Field to Thomond Park in view of the huge crowd expected to

see the game.

Limerick AFC, said: "Waterford want
over 6,000 tickets for their support-

ers

"If we were to accede to their demands the game could not be staged at the Markets Field which can only cater for 6,000 people."

An estimated 16,000 will want to see the "plum" game of the second round. Limerick AFC will meet Directors of Limerick Greyhound Track Ltd during the week to discuss what precautions it would be take to prevent serious damage being caused to the Markets Field, should the club decide to stage the cup on their "home" ground.
