SINN FEIN COUNCILLOR OBJECTS TO MEMORIAL PROJECT

MR P Mulcahy stated at last night's meeting of the Corporation that he would not be a party to any memorial that excluded the men of 1922 and '23 when the question of a site for a memorial to the murdered Mayors of Limerick in 1921 and Comdt Sean Wall, came up for consideration.

The Memorial Committee proposes a site at Strand House, but the City Manager (Mr M Macken) told the meeting that before agreement to the suggestion, the more advice they got the better. It was most important that a suitable site be chosen for the memorial and there would have to be consultations between th Town Planner ad the architect. They had to ensure that somebody would not go

ahead and erect a memorial without consultations.

The Mayor said that on Tuesday last he attended a representative meeting of the Memorial Committee, which included Mr John Sheeha, Chairman of the Limerick Men's Association in New York' former Mayors of the City, the Chairman of the County Council, Mr J.J. Collins TD, and Mrs M Clancy and Mrs K O'Callaghan. The meeting was unanimous that no more worthy cause could be inaugurated and it was decided to set up a Provisional Committee, of which he was elected Chairman and Mr Collins Vice Chairman. The memorial would be to commemorate the East, West and Mid-Limerick Brigades, and appeals towards the costs would be made throughout the city and county, which he felt would get substantial support. He did not think that three names were held more dear in Limerick than George Clancy, Michael O'Callaghan and Sean Wall and it would be a monument to all those who gave their lives for the cause of Irish freedom.

Mr JP Liddy asked if the name of Jospeh O'Donoghue, who was murdered on the same night as George Clancy and Michael O'Callaghan, would also be commemorated.

Mayor: Yes. This is a monument to commerate all. full support to the project, but our only function here is to grant a site or not.

It was unanimously agreed to grant a site for the memorial.

ALDERMAN DESCRIBES ESB ANTICIPATION AS HIGH-HANDED
