## Former Cinema Operator Doing Well In Art

A former Limerick cinema operator who had a flair for artistic painting has secured recognition in the Parisian publication, "La Revue Moderne," which is devoted to illustrating and commenting on prominent works of art.

The artist, Mr. Thomas Greaney, whose home address is at 2 Rossa Villas, Garryowen, Limerick, had an oil painting hung at the London Royal Institute of Oil Painters' Exhibition recently. It was so well received by the international connoisseurs of art that it was given honourable mention, with an illustration of the painting, in the French monthly publication.

The journal praised the quality of Mr. Greaney's scenic subject and commented that up to that he had only exhibited in provincial towns and his only training in art was at the Limerick School of Art, Municipal Technical Institute, which at that time was under the direction of Mr. R. Butcher, now deceased.

Mr. Greaney first attended the "Tech" as a boy in the 1941-'42 session. He returned in 1945 and was there until 1950. He is now doing commercial art in London and those who can speak with authority on art say that he has a very bright future.

The Justice imposed a suspensory sentence of one month on each of the first three defendants and he sentenced Mary Bourke to a month's imprisonment. He remarked that there was a good deal of complaints from citizens about the conduct of the defendants.
