What must he think of our restricted powers of walking and jumping, to say nothing of our alcoholic habits and our moral tone, so infinitely lower than that of any respectable canine personage? It is true, too, that man is the only animal which has to be taught the use of his natural weapons in fighting. All others know how to attack the vital part of an enemy while exposing themselves as little as may be, and taking advantage of any little circumstance which tells in their favour.

SERIOUS ASSAULT ON PRISON WARDERS:

Mr. J. French, R.M., attended at Limerick County Prison yesterday and held a magisterial investigation into a charge of assault preferred by the Governor, Mr. O'Sullivan, against John McGrath, a prisoner undergoing a sentence of two years' hard labour, on a conviction at Nenagh last October for larceny. It appears that on Sunday, the 26th instant, McGrath was sentenced, on the complaint of Prison-warder Newman, to two days' extra punishment for insubordination, and at a quarter to one o'clock on the same afternoon, on Warder Scales bringing the prisoner his dinner, he struck the warder on the head and face, and it was not until Newman arrived on the scene that the two warders succeeded in overpowering him. They were all cut and bleeding, and had to be medically treated by Dr. McGrath for incised wounds on the head, neck, and face. The attack having been reported to the Governor, a search was made in the prisoner's cell and the handle of an iron vessel found. Evidence was given by the doctor that the injuries could have been inflicted by the handle (produced). The Governor stated that McGrath only expressed regret that he could not give the warders more than he did, and that he would give him (the Governor) what he was sure he often got in Belfast. The depositions having been completed, McGrath made a long statement, to the effect that he suffered from heart affection, that he received rough treatment, and that what he did was in self-defence. McGrath was returned for trial to the Winter Assizes.

IRISH PRIEST DIES IN AUSTRALIA.

The "Ararat Chronicle" has the following: We regret to have to chronicle the death of the Rev. Father Carroll, who, after a protracted illness, passed away at the R.C. Presbytery, from consumption. The deceased, who was 31 years of age, was a native of Kilmallock, Co. Limerick. He was educated at Maynooth College, near Dublin, and was ordained seven years ago. After Requiem Office and High Mass at St. Mary's the remains were interred in the Ararat cemetery. The funeral was a large one.
