

# THE WAR.

## JAPANESE VICTORY.

### Surrender of Sakhalin.

Tokio, Friday.

The following official report has been received: Details of the pursuit, final stand, and order of the majority of the Sakhalin

On the afternoon of July 28th, a column acting independently, attacked and defeated the enemy at Palep, and drove them back, capturing two field guns, besides ammunition. On July 29th the column had been reinforced, and vigorously pursued the enemy south of Taylan, which is 100 miles south of Rykoff. The enemy, General Onol, 25 miles south of Taylan. On the morning of the 30th, and the day following, the Japanese were in a lamentable state with a flag of truce, and a letter from General Liapanoff, the Governor of the island, saying that he was in a desperate straits for bandages and medicines, it was, consequently, impossible to refuse the wounded. He was, therefore, by his sense of humanity to cease

the Japanese Commander, in his reply, that all war supplies and Government property should be handed over intact, with all maps, records, and papers of civil and military administrations. It is noted that the Russian reply should be received by 10 o'clock on the morning of the 31st, otherwise an attacking movement would be made immediately. Colonel Koizumi, who met Colonel Koizumi, Chief of the Japanese Staff on the morning of the 31st, laid down the terms laid down by the Japanese. The governor, 70 officers, and 100 thereupon surrendered. The spoils, including clothing, papers, and supplies, are being examined."

## LAMENTABLE FATALITY AT BALLYBUNION.

### Plucky Rescue.

On Thursday evening Dr. Clancy, J.P., Listowel District Coroner, held an inquest touching the death of the Rev. J. Conway, C.C., Shanagolden, Co. Limerick, aged 48 years, whose body had been taken out of the sea at Ballybunion some hours previously. From the evidence, it appeared that the Rev. gentleman went bathing with another clergyman, who was unable to render him any assistance owing to the heavy sea, and only got ashore with considerable difficulty. The Rev. Mr. Fry, Rector, with characteristic pluck, swam to the assistance of the drowning clergyman, and brought him ashore, but it appeared that life was then extinct, as the most vigorous efforts at artificial respiration failed to restore consciousness. In accordance with the evidence of Dr. Costelloe a verdict of death from drowning was returned.

### THE FUNERAL.

The funeral, which took place to-day for Mount St. Laurence Cemetery, was both large and representative. The people of Foynes, Shanagolden and Robertstown attended in large numbers. The remains were conveyed to St. John's Cathedral yesterday, and at 11 o'clock this morning, after Solemn Requiem High Mass was solemnized, the Most Rev. Dr. O'Dwyer presiding, were removed for interment. The celebrant was Rev. J. Conway C.C., Glin; deacon, Rev. J. Mangan, C.C. Bulgaden; sub-deacon, Rev. Fr. Casey, and Master of Ceremonies, Rev. J. ## DEATH OF MR. JOHN KEARNEY, H.M. CUSTOMS.

We regret to announce the death of Mr. John Kearney, Examining Officer of Customs at this port, which took place on the 3rd inst. at St. John's Hospital. He was stationed in this city for upwards of seven years, and was most popular with his colleagues and the public.
