CITIZEN OF YEAR: DENIS LEONARD

MR. DENIS Leonard, chairman of Limerick Civic Trust, the first organisation of its kind in this country, was this week named Limerick Citizen of the Year, 1983.

The award was organised by Junior Chamber Limerick and sponsored by the Irish Civil Service Building Society.

As the Limerick Image Project chairman, Mr. Leonard, a native of Limerick, spearheaded and worked unceasingly to implement the objectives of the committee.

Objectives

Their original objectives were to present nationally and internationally the many outstanding attributes of Limerick, and to act as a local liaison group to assist with the smooth transfer to Limerick of the Revenue Commissioners staff, as announced by the Government.

The committee was formed with 20 statutory and voluntary organisations actively participating.

The committee decided to expand its activities to include the restoration and preservation of historic buildings. Thus the Limerick Civic Trust was created.

Since 1976, six recipients have been awarded the prestigious title, Limerick Citizen of the Year.

The award is made to "the person, organisation or group, who has contributed most to an awareness of citizenship in Limerick."

The past recipients included Mr. Joe Scallon, for his work with the Vizes Court Homes; Brother Anthony Ferri, for his work with the Simon Com-

munity; Fr. Vincent Kava-

nagh, for his social work in the city; Mr. Michael Daly, for his efforts in attracting industry to the Limerick region; Mr. Eoin Hand, for his contribution to the sporting activities of the city; and Mrs. Brid Dukes, for her cultural contribution in establishing the Belltable Arts Centre.
