THE IRISH TOURIST TRAFFIC.

The tourist season in Ireland is now drawing to a close, and those who are in a position to speak authoritatively on the subject declare that the traffic has been a fairly satisfactory one, all things considered. . One thing which militated against it was the coal strike, now in existence for the abnormal period of four months, and yet remaining unsettled. The great dislocation of trade and the loss of earning power which it has caused in Great Britain naturally tightened the purse-strings of would-be holiday makers. But withal that, Ireland has had a reasonably good season, and with brighter prospects for that of 1927. great deal of important work was accomplished by publicity propaganda, in which the Tourist Associations and the British Railways and Steamship and Irish Companies heartily co-operated, and it safe to say the result was 'that large numbers of tourists were this season attracted to Ireland who never before enjoyed the charming and varied scenery of this country. And in addition to the summer season, the establishing of an Irish Bureau in London some short time ago will prove valuable in bringing under notice the mild climate of certain parts of this country, which will commend itself to people who usually go to the Continent to winter there. Ireland possesses attractions for its visitors in winter as in the brilliant days of summer. We are noted for our love of hunting, and fine opportunities for the pursuit the pastime which exist in this land. Before the war it was the "happy hunting ground "for English sportsmen, and it is very cheery to remember that the. hunting season last year saw many familiar faces from across the Channel onco more in the field. There is little doubt that they will again Join in the chase during the coming winter and apring. On the whole, we have no reason to be dissatisfied with the result of the tourist traffic this year, especially the months of July and August, when there was a big number of American and cross-Channel tourists in the country, particularly during Horse Show Week, which was a record success in the annals of this great National fixture.

TECHNICAL EDUCATION.

The advantages of technical education have frequently been emphasised, and brought prominently before the public by calucationists and industrial chiefs. To-day the necessity for such training is even more requisite, and countries that have made it practically compulsory have benefited by it to a very great extent. In this country we are still a long way behind in the matter, but within recent years a good deal of leeway has been made up. City Committee Formed.

Bags Seized by Armed Men.

Two men armed with revolvers and disguised, yesterday morning robbed the Galway mail car on its way to Kilcolgan and Ballyvaughan. City Improvement Contract.

Fair Wages Question.

At the meeting of the Corporation Improvement Committee last night, a letter was redd from Mr J. J. Dundon, Law Adviser relative to the contract entered into with Mr Thomas Gough for concreting a specified area of streets and footpaths in the city. The Law Adviser pointed out that he had submitted the draft contract to Mr Gough, which contained a condition for payment of wages to labourers at the rate of 1s 33d per hour. Mr Gough replied that tender, and that it represented a new and onerous clause. Mr. Dundon went on to say that there seemed to be substance in this complaint, but that the letter from the Ministry of Local Government of the 9th instant directed a clause to be substituted for the payment of fair wages, leaving a blank for the rate per hour or day to be filled in by the Council. It was added that the Ministry could not have contemplated that the wage should be at the rate of 1s 32d an hour, and that being so, Mr Dundon was of opinion that the Ministry should be asked to state the rate of wage which they would be prepared to sanction.

After a discussion, it was decided to refer the question to a sub-committee, with a view to an arrangement being come to with Mr Gough for the carrying out of the contract.

FREE STATE

And Council of League of Nations.

The Irish Free State has claimed a seat on the Council of the League of Nations. The following is the text of the Note from the Irish delegation to the League of Nations," which has been circulated to the delegates of the British Empire :-

"I have been instructed by the Irish delegation to request you to be good enough to inform your delegation that, after careful consideration of the position reviewed at the meeting of the heads of Commonwealth delegations this afternoon, it has definitely decided to proceed with our candidature for a seat on the Council.

The Irish delegation believe that this step will best serve the interests of the Dominions, and hope that their candidature will meet with the support of your delegation.

'(Signed): J. P. WALSHE, Secretary." This Note was discussed last night at a full meeting of the British Empire delegation. The proceedings were harmonious and friendly (says Reuter's correspondent), and there was general agreement on the principle that the Dominions had a good claim to a seat, but, at the same time, expression was given to the feeling that the present moment was inopportune for pressing it.

The delegations retained complete freedom of action, but, as to the British attitude, it is pointed out that certain promises had been given to various countries before Ireland's claims were put forward.
