Varnish gang swood on cemetery chapel

IN THE WAKE OF FURTHER VANDALISM, Deputy Jim Kemmy this week called for a new roof to be placed on the sacristy of the 100-year-old church of St. Laurence, at Mount St. Laurence Cemetery. Youths this week attempted to gain entry through the sacristy roof. And they defaced a tombstone with nail varnish.

They had apparently been sniffing nail varnish.

Recently vandals succeeded in getting in through the roof and stealing equipment used by the men employed on the Corporation Social Employment Scheme cleaning the cemetery.

"The roof in its present state is only an invitation to vandals," Deputy Kemmy told the Limerick Leader. "The slates are being loosened with each attempted breakin."

Safety

In an attempt to ensure the safety of their equipment, the men employed on the Social Employment Scheme have placed sheeting on the holes in the roof.

"The only solution seems to be a new roof," said Deputy Kemmy.

Mr. John Bradish, foreman at the Cemetery for the past 40 years, agreed and added: "The lead in the valley of the roof has also been removed by the vandals leaving all the slates loose."

Mir. Seamus O'Sullivan, Corporation engineer, in charge of the cemetery, said that the Corporation officials were intending speaking to the Bishop's office on the future of the building.

Sniffing

It would appear that the vandals who broke into the grounds this week were sniffing nail varnish, as up to 20 bottles of the product were found on the ground beside the sacristy.

Referring to the nail varnish, Deputy Kemmy renewed the call to pharmaceutical outlets to be extra vigilant in selling the substance to young people.

He also called on the gardai to keep an extra eye on the city cemeteries during the summer months.
