The workers were suspended after they refused to comply with the transfer of some of the service users and carers from the residential centre at Bawnmore to a commu-

"This is a very unfortunate situation but our members have been locked out for over a week now. We have repeatedly asked the Brothers of Charity to allow them back to work but they have refused to do so," Karan O'Loughlin the SIPTU branch organiser said.

"At a general meeting on Monday March 27, over 100 Brothers of Charity employees turned up in support of the 14 locked out workers. The general feeling at the meeting was that the lock-out is an outrageous way to treat employees in this day and age," she commented.

because they said that no agreement on staffing levels for two of the houses had been agreed on. This, they said, left the houses in an under-staffed position.

SOUTHILL Anthony Kelly, spent Tuesday afternoon in court appealing a decision by the Department of Social Welfare who have denied him a disability allowance.

The Southill claimed he was entitled to the weekly allowance of €165 despite the fact that he has spent over €100,000 since ĥe sold his Fedamore home in June 2004.

Mr Kelly's Barrister, Andrew Sexton, told the Circuit Court that his client does not have assets or an income and that he cannot work, and so is therefore entitled to the allowance.

He said rumours of Anthony Kelly's past had "led the State to treat him in an unfair man-

Speaking on behalf of the State, Mark Nicholas BL, told the court it was purely a social welfare case and that Mr Kelly "did not answer the questions sufficiently to allow this allowance

Social Inspectors accept that Anthony Kelly has a disability and is unable to work. His injuries are as a result of gunshot wounds inflicted during a local dispute.

The Department's refusal to grant Mr Kelly a disability allowance centred on the sale of his house in Fedamore in June 2004 which Mr Kelly benefited from to the tune of €118,000.
