


FEARS are growing that the proposed euro 20m greyhound stadium on the Ennis Road, on a site to the rear of the Two Mile Inn Hotel, might have to be shelved, because of objections.

Gus Ryan, track manager at the Markets Field, warns that the planning objections which recently surfaced needed to be addressed immediately. And he has called on all public representatives in the region to lend their weight and ensure that obstacles are overcome.

"There is a very important meeting planned by Bord na gCon for next Monday involving Clare County Council. If problems continue to persist about the suitability of the site acquired last year, it is reasonable to assume that the Bord will be obliged to walk away and look for an alternative landbank.

"We cannot afford to wait any longer. The money is there to be drawn down and the danger is, that if there are any further delays it might be diverted to other stadia. Those involved in the industry, owners, trainers, sponsors and supporters, have shown remarkable patience down through the years and latest developments are not at all encouraging".

In the latest twist, the Irish Examiner exclusively reported last week that environmental concerns had been expressed for the otter population by An Taisce, who had made a submission to An Bord Pleanala.

Said Ryan: "This is ridiculous, the last time an otter was seen in that area of the Ennis Road was when a fella' produced one from his pocket. I'd be prepared to send out a search party looking for otters. The whole thing is laughable"

HE REVEALED that objections to the state-of-the-art track were also submitted by the Two Mile Inn and the National Roads Authority, the latter flow of traffic likely to be generated by the new stadium.

Back to Ryan: "Since the track will be open for business only in the evenings, I don't foresee any traffic congestion on the Ennis Road".

It had been hoped to unveil the new stadium inside the next 12 months but at the current state of play, it could be that length of time before the first sod on the site is turned.

A spokesperson for the Limerick and

Clare Greyhound Owners and Breeders Association, said they were dismayed that the project was now almost certain to be delayed.

"There was a press conference held at the Castletroy Park Hotel earlier this year at which plans were presented, and all were excited that we were at last to get the facility that we deserved. We have been waiting 10 years to get out of the Markets Field and now this happens.

"It could take at least a further 10 months before any planning permission is granted, and another two years to build the stadium. I ask you, where are we going. Why is it that we always seem to have problems when it comes to doing anything positive for Limerick"

Meanwhile, Gus Ryan has appealed to all public representatives in the Mid West to row in behind them.

"This saga has been ongoing for far too long. Just when we had our hopes raised, this happens. The Markets Field is way past its sell-by date, the track promised would be a great acquisition to the region and would generate a lot of revenue. Our representatives in Dail Eireann and on the local authorities simply must get involved and apply the necessary pressure to ensure that our dream home is realised.




