The woods & underwoods are to be held to feoffor's use for life, & then, with all the residue after performance of the foregoing, to William's use, in t.m., remainders in t.m. to John Wogan, to Oliver Wogan, to feoffor's heirs male, to Robert, s. of Robert Wogan decd., to Oliver, s. of James Wogan, decd., to Edward Wogan of the Grange, to Thomas Wogan of Newhall, to the heirs male of David Wogan of Newhall, decd., to feoffor's lineal heirs female, & finally to the right heirs of John Wogan for ever. William Sutton of Tipper, gent., attorney to deliver seisin. W to delivery of deed:— Nicholas Wogan, Walter Sedgrave, Mathew Handcock, Peter Delahoid, Ro. Wogan, William Talbott of Robertstowne, Gerald fitz Gerald, James Flattsbury, Robert Flattsbury. 8 Nov 1618,. Dublin. From CA. Not in calendar.

Patrick Sedgrave of Dublin, merchant, d. wihtout issue 30 June 1698, seised of a house in Dublin. Heiress:— Sister Anne, then aged 60 & married Michael FitzSymon of Grangemore, co.Kildare, gent., s. & h. of James Fitz-Symons granted the premises to Nicholas FitzSymons for ever 1609. (Ferguson's index also gives names Margaret Fitzsimons of Dublin & Christopher Sedgrave of Rathgar, but without indicating relationhip).

William Bourke, PM

21 Nov 1618. Dublin, the King's Courts. From TCD. Not in calendar.

Sir William Bourke, lord Bourke of Castleconnell, was seised of 2 carucates in Meanns, Killelen & Clownenaghan (exept 1 qr.), co. Limerick, $\frac{1}{2}$ a qr. in

Knockanmellan, 3 parts of a qr.in Means Eighteragh, $\frac{1}{2}$ a carucate in Garynoe in the co. of the city of Limerick, Grangkey (except 4 carucates), Gortrobert 1 qr, Derry & Camas containing $\frac{3}{4}$ of a carucate, Carewecrahin 1 qr. & Radownn 1 qr. On 13 Apr he executed a mortgage of Garynoe. (1)

He was also seised of the 4 qrs of Castleconnell, a fishery called Kallen Illan & \(\frac{1}{4} \) of a fishery called Molligee in Ballitroy in said county. On 13 Sept 1576 he granted 2 quarters of the said fishery to Any ny Rury & Thomas Mc Adam,. (2) He also granted \(\frac{1}{4} \) of a fishery in Collatray in Cullmuckgee to William Fitz William for 12 loaves of bread & 1 barell of bargat ("potus mellitis, anglice a barell of bargat") & 12 candles.

He was also seised of 2s. rent from Clonclei....... 10s. from Ballyshynnon in the co. of the said city [of Limerick] & 10s. & Ballyvarra in the co. of the said city, 13s. 4d. from Ballylosky, 4s. from the 6 carucates of Curraghmore, 8s. from Carrigbeg & Dromboy in the co. of the said city, 13s. 4d. from Killanan, Garryparson, Shrowhan & the 2 carucates of Rotheston, ½ a carucate in Cullynan, 2 carucates in Ballynecloghy He d. on July 26 Eliz (1584) & the premises descended to his grandson & heir, John Bourke of Castleconnell, s. of his s. Theobald. John d. at Hunslowe in England & the premises descended to his bro. Richard.

On 11 Mar 1594 Richard mortgaged 2 parts of the carucate of Granyky, the mill of Garra & 3 parts of the carucate of Clonkeen to Robert White for £90. (3-5) On 8 Oct 1595 he mortgaged the carucate of Camuse to William Streech of the Middle Temple for £56. (6).

Richard d. 28 Feb 1599 at Ballynecarge, co. Limeirck & the premises descended to Thomas his bro. Thomas d. on the same day at Ballynecarge aforesaid. Every carucate of the above is worth 10s.

Edmund, now lord Castleconnell, is the s. & h. of Thomas & was 3 or 4 months old at his father's death, & Theobald Bourke, then lord Bourke & now baron of Brittas, took all the profits from the death of Thomas to the present.

Limerick, bounded on the E by Ballyleskie, on the W by Ballyvikcahill, on the S by Bally Emlye & on the N by Carrhwen Tauley, provided that it after 6 years from All Souls Day next mortgagor repay the princpal of £11 stg., with 2 milch cows with their calves, between SS Philip & James' day & St. Brandan's day, he may re-enter in 12 months' time. Richard Mc Hubbard of Cnockwess....y & Redmond McWilliam of Ballylaskie attorneys to deliver seisin. Forfeiture of patents to Dermot Cavanagh. 11 Feb Dublin. From CA. Not in calendar.

Recites patent of 29 Apr 1592 regranting to Dermot ne Morishe Cavanagh & Crehen McDonell their lands which they had surrendered to the queen on 18 Dec 1591, & patent of 15 May 1594, granting to Dermot certain lands of Griffin Mc Morishe Cavanagh & Dermot O Wittn (in Fiants O Nittin), attainted. Dermot d. 11 Dec 1615. He had not complied with the terms of the grant. The premises are therefore taken into the kings hand.

George Dillon, PM.

12 Apr 1619, Kilmainham, before William Barker esq, feodary for Leinster, & William Roulls, deputy of Walter White, escheator, under commission of 29 Jan 1619.

Patrick Colgan of Killeigh, Co. Dublin, yeoman, was seised of 1 mes., 24a. & a watermill in Killeigh, to the use of George Dillon of Killeigh, gent, decd, held in chief by knight service, & of 7 mes., 1 toft, a mill & 82a. in Killeighe, to the same use, from whom held the jurors do not know. In Hilary term 1598 John Chevers of Mareston, esq., & John Bath of Balgriffin, esq., recovered the same against him, to the said use. John is now dead. George Dillon d. 20 Mar 1619. Heir: - s. Luke, aged 27 & unmarried.

Agnes Ryan, PM.

5 June 1619 Dublin. From CA. Not in calendar.

James Ryan of Dublin, gent, was seised of tenements in Dublin held of the mayor etc. On 22 Nov 1593 he enfeoffed Nicholas Begg & Christopher Birford to the uses of his will, which he made on 24 1593, bequeathing certain rents to Matilda Mannening his wife, for life, remainder to Mary & Agnes, their daus, & their heirs. On 22 Nov 1593 he granted certain tenements to Nicholas Begg & Thomas Brandon, to the use of Patrick Cusack of Rathalron, gent., & Elanor Ryan, grantor's dau., who were about to marry, & to their heirs, remainder in case of failure of heirs or non-performance of the marriage to grantor & his heirs (1) James' heiresses were his daus., Elanor, Mary & Agnes, aged 13, 11 & 8 respectively at their father's death. Matilda received her rents for life, & d. 21 Sept 1618. After James' death Mary married Richard Noble & had a dau., Alison. Richard survived Mary, & d. 29 Sept 1609, Alison being then 9. The feoffees were seised of half the tenements after James' death to the use of Agnes. She d. 20 Feb 1609(2) & her heir was her s. James Young, then aged 18 & unmarried.
